FOURTH AMENDATORY AGREEMENT

THIS FOURTH AMENDATORY AGREEMENT is made between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado, and SECURITAS SECURITY SERVICES USA, INC.

RECITALS:

WHEREAS, the Parties entered into an Agreement dated December 23, 2021, an Amendatory Agreement dated December 13, 2022, a Second Amendatory Agreement dated June 6, 2024, and a Third Amendatory Agreement dated November 14, 2024 (collectively the "Agreement"), to undertake, perform, and complete all of the services and produce all the deliverables set forth in Exhibit A-1, the Scope of Work, to the City's satisfaction; and

WHEREAS, the Parties now wish to modify the Agreement to extend the Term, and to increase the Maximum Contract Amount.

NOW THEREFORE, in consideration of the mutual covenants and agreements hereinafter set forth and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties incorporate the recitals set forth above and amend the Agreement as follows:

- 1. Capitalized terms used but not defined herein shall have the meanings given them in the Agreement.
- 2. Section 4 of the Agreement, entitled "<u>TERM</u>:", is hereby amended to read as follows:
 - "4. <u>TERM</u>: The Agreement will commence on January 1, 2022 and will expire on December 31, 2026 (the "Term"). Subject to the Executive Director's prior written authorization, the Contractor shall complete any work in progress as of the expiration date and the Term of the Agreement will extend until the work is completed or earlier terminated by the Executive Director."
- 3. In Section 5 of the Agreement, entitled "<u>COMPENSATION AND PAYMENT</u>:", Subsection D entitled "<u>Maximum Contract Amount</u>:", Subparagraph 1 is hereby amended to read as follows:
 - "1. Notwithstanding any other provision of the Agreement, the City's maximum payment obligation will not exceed **SEVENTY-ONE MILLION**

TWO HUNDRED THOUSAND DOLLARS (\$71,200,000.00) (the "Maximum Contract Amount"). The City is not obligated to execute an Agreement or any amendments for any further services, including any services performed by the Contractor beyond that specifically described in **Exhibit A-1**. Any services performed beyond those in **Exhibit A-1** are performed at the Contractor's risk and without authorization under the Agreement."

- 4. As herein amended, the Agreement is affirmed and ratified in each and every particular.
- 5. This Fourth Amendatory Agreement will not be effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.
