5. General description or background of proposed request. Attach executive summary if more space needed:

This request approves a rescission of \$18,800,000 from General Fund contingency so that a cash transfer can be made from the General Fund to City Attorney's Liability Claims Fund (11827-4510000), and an increased appropriation of \$18,800,000 be established in the Fund. This will provide budget capacity to fund settlements and claims previously approved and/or in process.

General Fund Contingency started the year with a balance of \$33,475,962. There has been one supplemental year-to-date made from General Fund Contingency in the amount of \$3,000,000, approved via ordinance 0758, series of 2026, which has left a balance of \$30,475,962. If this item passes, the total remaining contingency will be \$11,675,962.

The Liability Claims Fund started the year with a balance of \$2,668,521, which included a General Fund Transfer of \$2,000,000 per ordinance 1813, series of 2025. There fund has received one previous supplemental this year in the amount of \$3,000,000.
