A BILL

For an ordinance making a supplemental appropriation in the Denver Arts and Venues Special Revenue Fund.

9 **WHEREAS**, Denver Arts and Venues is experiencing increased costs, including higher
10 minimum wage rates, cleaning and janitorial services, film and theater production support services,
11 public order and safety services, security and personal safety services; and

12 **WHEREAS**, expenditures will be offset by revenue and will result in a net zero change in the
13 agency's year-end fund balance;

15 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**
16 **DENVER:**

18 **Section 1.** From the Denver Arts and Venues Special Revenue Fund, Accounting No. 15815
19 not otherwise appropriated and in addition to amounts heretofore appropriated by Ordinance
20 No. 1539, Series of 2024, and any supplemental appropriations or rescissions, there is hereby
21 appropriated to the appropriation accounts hereinafter designated the amount of money following
22 such designation, to be expended for the purposes and upon the authorizations in said Ordinance
23 set forth:


