**A RESOLUTION**

**Approving and providing for the execution of a proposed Grant Agreement between the City and County of Denver and the U.S. Department of Housing & Urban Development (HUD) concerning the “HOME - American Rescue Plan Act (ARPA) FY2022” Program and the funding therefor.**

**WHEREAS**, the City and County of Denver has given due consideration to said proposed Grant Agreement;

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** The proposed Grant Agreement, between the City and County of Denver and the U.S. Department of Housing & Urban Development, for the a HOME Investment Partnership through the “HOME - American Rescue Plan Act (ARPA)” program, which is identified as Grant Number M21-MP080204, a copy of which is duly filed with the City Clerk, Filing No. 202161557, be and hereby is approved in all respects.

**Section 2.** The payments made by the United States of America to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Revenue Fund No. 16000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

**Section 3.** That it be and is hereby found and determined that the budget summary of said program, to be expended by the Executive Director of the Department of Housing Stability, is as follows:

1 The foregoing is an America Rescue Plan grant to assist individuals or households who are  
2 homeless, at risk of homelessness, and other vulnerable populations, by providing housing, rental  
3 assistance, supportive services, and non-congregate shelter, to reduce homelessness and increase  
4 housing stability across the country. These grant funds will be administered through the HOME  
5 Investment Partnerships Program (HOME). Authorization for expenditures of said funds will cover  
6 the period from September 2021 to September 2030.

9 and directed to make such book and record entries and to do such other things as may be necessary  
10 to accomplish the purposes of this Resolution.
