- I am currently assigned to oversee Sector 1 in District 3, which covers a larger and diverse area of residential, business, and urban communities.
- To meet the community needs, I implemented a fulltime Homeless Out Reach Team for District 3.
- Because of my extensive background in Critical Intervention training, operating as a Crisis Negotiator, and being on the team to first assist in the implementation of Mental Health Clinicians (2016) in District 3, I oversee our newly instituted City Case Manager and coordinate closely with our MHCD Clinicians.
- As I came from a training background as a Denver Police Academy Instructor, I believe in the importance of continuing to strive to move forward and engagement with our community partners. To help accomplish this I worked on a committee with the The Center (LGBTQ+) to provide training for the Law Enforcement community to engage diverse communities with education, dignity, and respect. As also being an Out member of DPD, I believe it is important to have different views at the table so all voices can be heard.
- Previous to being promoted to Lieutenant, I was a sergeant assigned to the Domestic Violence Unit and Bias Motivated Crimes investigations. Since both can impact a community at its core, I believe it is important that we give people and communities a safe place to disclose information and be able to have options to seek confidential assistance; sometimes without police involvement. For this reason my time working with the Rose Adom Center, was instrumental in helping me to bring those perspectives to my daily duties.
