9 For an ordinance approving and providing for the execution of a proposed grant
10 agreement between the City and County of Denver and the State of Colorado
11 concerning the "Promoting Safe and Stable Families FY10-11" program and the
12 funding therefor.

14 WHEREAS, the City and County of Denver has given due consideration to said proposed
15 Grant Agreement;

16 NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY
17 OF DENVER:

18 Section 1. The proposed Grant Agreement, under CFDA No. 93.556, between the State of
19 Colorado, Department of Human Services, Division of Child Welfare and the City and County of
20 Denver, which is identified as Grant Number 10-IHA-2985, a copy of which is duly filed with the
21 City Clerk, Filing No. 09-1294-B, be and hereby is approved in all respects.

22 Section 2. The Mayor or his lawful successor and other proper officials of the City and
23 County of Denver, in its behalf, are hereby authorized and directed to execute said Grant
24 Agreement and the Clerk and Recorder of the City and County of Denver is hereby authorized
25 and directed to attest and impress the official seal of the City and County of Denver on the Grant
26 Agreement.

27 Section 3. The Mayor, his successor in office, or his duly authorized representatives, and
28 other officials of the City are hereby authorized and directed to do all things required to be done
29 in order to obtain payments under the Grant Agreement, including, but not limited to, filing
30 requests for payments, contracting with persons and organizations in order to carry out the
31 provisions of the Grant Agreement, filing reports and keeping records relating to fiscal and
32 evaluation matters, and forwarding other materials to the State of Colorado.

33 Section 4. The payments made by the State of Colorado to the City pursuant to and under
34 the Grant Agreement shall be deposited into the Treasury of the City and credited to Special
35 Fund No. 13000, which is set forth and described in Section 20-18 of the Revised Municipal
36 Code of the City and County of Denver.

1 Section 5. That it be and is hereby found and determined that the budget summary of said
2 "Promoting Safe and Stable Families FY10-11" Program, Accounting Number 13001-5511101-
3 H2119, is as follows, to be expended by the Manager of Human Services.

4 State of Colorado \$403,750

5 An in-kind match in the amount of \$173,036 is required by the Grant and will be provided by
6 Human Services and partner community based agencies.

7 Authorization for expenditure of said funds following execution of said grant will cover the
8 period from October 1, 2010 to September 30, 2011.

9 Section 6. The Manager of Finance of the City and County of Denver is hereby authorized
10 and directed to make such book and record entries and to do such other things as may be
11 necessary to accomplish the purposes of this Ordinance.
