General description of proposed ordinance including contract scope of work if applicable:  Crime Prevention and Control Commission has contracted with the Mental Health Center of Denver to provide Assertive Community Treatment "ACT" to mentally ill-homeless persons in the Court to Community court intervention program. The proposed contract provides for a one-year agreement extension (FY2013) that cumulatively exceeds the threshold contained in Section 3.2.6(E) of the Charter requiring City Council approval. The proposed one-year amendment cost is \$90,000 and the total cumulative cost will be \$821,839.		
	ACT Services, an evidence based wrap-around high intensity treatment model is provided by Colorado Coalition for the Homeless (CCH). CCH and Mental Health Center of Denver are the only two providers licensed in Denver to provide this service. Each ACT slot has an average cost of \$12,000 per person. Persons average 18 months in treatment before becoming stable. Clients receiving ACT services show a marked reduction in new arrests as well as reduction in detox, emergency and hospital stays.
