7 For an ordinance setting the salary of the district attorney for the second judicial district.

9 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

10 **Section 1.** That section 18-95, D.R.M.C. shall be amended by deleting the language stricken  
11 and adding the language underlined, to read as follows:

12 (b) Salary of district attorney.

13 ~~(1) For 2017 and 2018, the district attorney of the second judicial district shall continue to be~~  
14 ~~paid an annual rate of two hundred nineteen thousand six hundred six dollars (\$219,606.00).~~

15 ~~(2) Effective January 1, 2019, the district attorney of the second judicial district shall be paid an~~  
16 ~~annual rate of two hundred twenty three thousand nine hundred ninety eight dollars (\$223,998.00).~~

17 ~~(3) Effective January 1, 2020, the district attorney of the second judicial district shall be paid an~~  
18 ~~annual rate of two hundred twenty eight thousand four hundred seventy eight dollars (\$228,478.00).~~

19 (1) For 2021, the district attorney of the second judicial district shall not receive an increase in  
20 salary and shall be paid an annual rate of two hundred twenty-eight thousand four hundred seventy-  
21 eight dollars (\$228,478.00).

22 (2) Effective January 1, 2022, the district attorney of the second judicial district shall receive a  
23 one percent (1%) pay increase if career service employees under Denver Charter Sec. 9.1.1. are  
24 approved for merit increases in the adopted 2022 City budget.

25 (3) Effective January 1, 2023, the district attorney of the second judicial district shall receive a  
26 three percent (3%) pay increase if career service employees under Denver Charter Sec. 9.1.1 are  
27 approved for merit increases in the adopted 2023 City budget.

28 (4) Effective January 1, 2024, the district attorney of the second judicial district shall receive a  
29 three percent (3%) pay increase.

30 ~~(4)-(5)~~ Future reviews of the pay assigned to the district attorney shall be conducted during the  
31 calendar year immediately preceding the expiration of the current term of such district attorney.
