Proclamation No. 18-0595

Designating May 20th through May 26th as “Public Works Week in Denver” and Congratulating the Denver Public Works Department’s Twelve Employees of the year for 2017

WHEREAS, in celebrating the American Public Works Association’s 2018 theme of “The Power of Public Works”, we recognize that Denver Public Works, through its 1,300 employees, is a dynamic force in our community, delivering safe, high quality, cost-effective services to the citizens of Denver; and

WHEREAS, the services provided by Denver Public Works are an integral part of our residents’ everyday lives, with programs that include street sweeping, recycling, composting, trash collection, street paving, snow removal and pothole repair; and

WHEREAS, Denver Public Works is proud to deliver services that enhance the quality of life in our city by managing and maintaining public infrastructure including streets, alleys, on-street parking, drainage ways, sanitary sewers, bridges, traffic signals, street markings and signage, as well as contracting, procurement, cashing and permitting programs that meet the needs of the public; and

WHEREAS, Denver Public Works will continue to deliver projects that align with Mayor Hancock’s Mobility Action Plan to provide people with more transportation choices and make biking, walking and taking transit easier and more convenient; and

WHEREAS, Denver Public Works will strive to create safe streets for everyone, with improved pedestrian crossings, bike facilities and roadways, ample crossing times, and improved sidewalk networks to achieve zero traffic deaths and serious injuries by 2030, as outlined in Denver’s Vision Zero Action Plan; and

WHEREAS, Denver Public Works’ vision is to be the ideal Public Works Department in the country and will meet expectations by coming together as a team, investing in our people, operating with discipline, using data to drive decisions, and delivering results; and
