**Subject:** Proposed Change to the Classification and Pay Plan

**The proposed change amends the Classification and Pay Plan by changing the pay grades of Airport Communications Center Supervisor, Airport Operations Supervisor, Ramp Tower Supervisor, and Terminal Operations Supervisor.**

Denver International Airport has requested to change its airport operations first line supervisor classifications from exempt to non-exempt. These four first line supervisors' classifications are required to work in a 24/7 shift environment 365 days a year. These four job classifications are used only by Denver International Airport. This change will not impact any other job classifications. It is proposed to align these job classifications' pay grades to the nearest non-exempt pay grade based on a comparison of midpoints.

Career Service Rule 7-37 Effective Dates, Section A: If it is determined that changes to the classification and pay plan are necessary, the effective date of any resulting changes to the classification and pay plan shall be the beginning of the first work week following approval by the Mayor or by the City Council over the Mayor's veto.
