A BILL

For an ordinance creating a Fund Number in the Grant/Other Capital Projects Fund for the Denver Road Home Improvements project and the funding therefor.

WHEREAS, the Lawrence Street Community Center is a Downtown Denver TIF project that supports goals outlined in the Shelter System of Denver’s Ten-Year Plan to End Homelessness administered by Denver’s Road Home; and

WHEREAS, the City has executed a capital grant agreement with Denver Rescue Mission, which states that upon the opening of the Lawrence Street Community Center, the City will receive a contribution in the amount of \$2,266,000; and

WHEREAS, this funding will continue to support City homelessness goals and will be utilized for the acquisition of the property located at 405 S. Platte for the development of the new Solutions Center;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. A new Fund is hereby established in the Grant/Other Capital Projects Fund, Accounting No. 38000, for the project indicated in the following tabulation:
