5 **A BILL**

6 **For an ordinance making a rescission from and an appropriation in the Capital**  
7 **Improvements and Capital Maintenance Fund.**

9 **WHEREAS**, during 2020, the City entered into supplemental negotiations with the U.S.  
10 Department of Justice under Project Civic Access (PCA) to improve accessibility for individuals  
11 with disabilities; and

12 **WHEREAS**, negotiations were occurring during the development of the 2021 budget and in  
13 an effort to be proactive, the City appropriated budget for ADA improvements based on the draft  
14 list of contemplated facilities; and

15 **WHEREAS**, in January 2021, a four-year supplemental agreement with the Department of  
16 Justice (DOJ) was executed to address ADA improvements in 18 additional facilities not included  
17 in the original agreement; and

18 **WHEREAS**, the final list of facilities included City administrative and human services  
19 facilities, safety buildings, and performing arts venues, but did not include parks and recreation or  
20 library facilities; and

21 **WHEREAS**, as a result, there is now a need to rescind budget from the Parks ADA  
22 Improvements capital project and make an appropriation in another capital project to immediately  
23 address those facilities included under the four-year mandate; and

24 **WHEREAS**, the Capital Improvements and Capital Maintenance Fund has \$500,000 in  
25 Contingency Funds available for these projects;

27 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**  
28 **OF DENVER:**

30 **Section 1.** From appropriations heretofore made from the Capital Improvements and Capital  
31 Maintenance Fund listed or indicated in the following tabulation there is hereby RESCINDED the  
32 amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred  
33 to the Capital Improvements and Capital Maintenance Fund:
