5 **A BILL**

6 **For an ordinance to amend Ordinance 898, Series of 2022, concerning the**  
7 **“Volume-Based Trash Pricing” program.**  
8

9 **WHEREAS**, Ordinance 898, Series of 2022 created the “Volume-Based Pricing” Fund for  
10 revenue and expenditures related to the Volume-Based Trash Pricing Program; and

11 **WHEREAS**, the City wishes to amend Ordinance 898, Series of 2022, to change the name  
12 of Fund 11886 to align with the specific use of the City’s Trash Pricing Program;  
13

14 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**  
15 **OF DENVER:**  
16

17 **Section 1.** Sections 1 of Ordinance No. 898, Series of 2022 is hereby amended to read as  
18 follows:

19 **Section 1.** A new Fund is hereby established in the General Government  
20 Special Revenue Fund Series, Accounting No. 11000, a “Volume-Based Trash  
21 Pricing Program” Fund, Accounting No. 11886, for the purpose of accounting  
22 for the receipt and expenditure of program dollars.  
23

24 **Section 2.** Sections 3 of Ordinance No. 898, Series of 2022 is hereby amended to  
25 read as follows:

26 **Section 3.** Program expenditures are hereby authorized for the  
27 “Volume-Based Trash Pricing Program” Fund, Accounting No. 11886, to be  
28 expended by the Executive Director of the Department of Transportation and  
29 Infrastructure. Allowable expenses include program costs to support Volume-  
30 Based Trash Pricing programs, including personnel, services and supplies,  
31 capital equipment, and appropriated cash transfers to the Capital  
32 Improvements and Capital Maintenance Fund for capital projects. The Chief

1 Financial Officer may transfer unused balances in the Fund to the General  
2 Fund. This Fund is appropriated and non-lapsing.

3  
4 **Section 3.** Sections 4 of Ordinance No. 898, Series of 2022 is hereby amended to  
5 read as follows

6 **Section 4.** That it be and is hereby found and determined that the  
7 budget summary of said program, to be expended by the Executive Director of  
8 the Department of Transportation and Infrastructure, is as follows:

11 The foregoing authorizes expenditures for the Volume-Based Trash Pricing Program.

13 **Section 4.** The Chief Financial Officer of the City and County of Denver is hereby  
14 authorized and directed to make such book and record entries and to do such other  
15 things as may be necessary to accomplish the purposes of this Ordinance.
