5. General description or background of proposed request. Attach executive summary if more space needed:

The purpose of the second contract extension with Arthur J. Gallagher Risk Management Services, LLC (Gallagher) is to ensure continuity of insurance broker services on Denver International Airport's (DEN) third Rolling Owner Controlled Insurance Program (ROCIP3). This program provides insurance, safety and loss control, and administrative support for DEN's major construction projects. The program is separated into three tiers. Tier 2 is dedicated to the Great Hall Project Phases 1 and 2. Tiers 1 and 3 include the Concourse Expansion Projects, Airside and Landside Annual Pavement Rehab Projects, Baggage Handling System and Pre-Conditioned Air Re-Life for Concourse A and C, among other projects. All three tiers are included in this extension of the contract.

The insurance broker, Gallagher, originally negotiated and implemented ROCIP3 and has provided continual administrative, loss control, claims management, and performance reporting services. They are also responsible for overseeing project and program closeout activities, including audits, and monitoring of any remaining open claims until closure. This contract extension does not add additional funds to the existing contract. ROCIP3 insurance policies currently expire on September 1, 2023 (Tiers 1 & 3) and June 1, 2024 (Tier 2). The insurance program will require extensions into 2024 (Tiers 1 & 3); 2025 (Tier 2) to address project completion dates extending past the natural program expirations, including the Great Hall Renovation Project (under Tier 2) and the Concourse Expansion Program (under Tiers 1 & 3). The extension also factors in time for closeout activities, final program audit, and open claims.

This contract is not adding any additional funds to the contract, rather, it is just a time extension for the ongoing work on of Gallagher. The original contract and the first amendment were both approved by City Council.
