5 **A BILL**

6 **For an ordinance amending the classification and pay plan for employees in the**
7 **Career Service and for certain employees not in the Career Service.**

9 **WHEREAS**, pursuant to 9.1.1 (C) and (D) of the Charter and Article I of Chapter 18, D.R.M.C.,
10 the Career Service Authority has recommended to the City Council an amendment to the classification
11 and pay plan governing the compensation of employees in the career service and certain employees
12 not in the career service;

13 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**
14 **DENVER:**

15 **Section 1.** That effective **July 10, 2011**, the classification and pay plan is hereby amended by
16 deleting the following job titles and associated pay grades, to read as follows:

<u>Job Title</u>	<u>Pay Grade</u>
Semi-Tractor Trailer Operator	615-J
Tow Truck Operator	612-J

20 **Section 2.** That effective **July 10, 2011**, the classification and pay plan is hereby amended by
21 changing the pay grade associated with certain job titles to read as follows:

<u>Job Title</u>	<u>Old Pay Grade</u>	<u>New Pay Grade</u>
Equipment Operator	612-J	613-J
Horticultural Worker	611-J	612-J
Parking Meter Collector	609-J	610-J
Senior Utility Worker	611-J	612-J
Utility Worker	609-J	610-J

29 plan kept and maintained in the office of the Clerk and Recorder, as reflected at Clerk Filing No. 11-
30 330-B, and at the Career Service Authority, and shall be available for public inspection both in person
