A BILL

For an ordinance making rescissions of budget balances to close out the “Community Corrections FY13-14” grant, rescind the budget balance and transfer the cash balance in the Public Safety Special Revenue Fund to the General Fund.

WHEREAS, the Community Corrections FY 13-14 grant (S3059) was created for Fiscal Year 2013 and 2014 activities related to the Community Corrections program; and

WHEREAS, all activities related to the grant are complete and this request is to close out the grant, rescind the budget balance and transfer the cash balance to the General Fund;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From authorizations of expenditures heretofore made and not rescinded, to the accounts indicated in the following tabulation there is hereby RESCINDED the amounts listed under the heading "Budget Balance Rescinded" and TRANSFERRED the amounts listed under the heading "Cash Transferred Out."
