EXECUTIVE SUMMARY

The purpose of the resolution is to set a public hearing on the service plan for the formation and establishment of nine (9) Title 32 metropolitan districts in the area generally referred to as the Aviation Station development adjacent to 61st Avenue and Pena Boulevard.

The Districts will be located generally North of 56th Avenue, South of 72nd Street, West of Tower Road, and East of Pena Boulevard. The Districts will provide for the construction, financing, operation and maintenance of certain public improvements which are necessary for the successful implementation of the Aviation Station development.
