If the individual, who is the subject of the search, had a case in Denver County Court, the Web Service provides the case related information. Only information that is considered public record is displayed. BIS has paid the City \$661,543.00 since the Agreement commenced in April 2011. It is estimated that an additional \$357,292.00 will be collected in the upcoming year.
