A BILL

For an Ordinance approving a proposed donation of surplus Firefighting Equipment from the City and County of Denver to Bomberos Voluntarios De San Pedro, Coahulia, Mexico.

WHEREAS, the City and County of Denver, through the Denver Fire Department, owns certain firefighting equipment; and

WHEREAS, Bomberos Voluntarios De San Pedro, Coahulia, Mexico, a volunteer firefighting company, identified a need for firefighting equipment and notified Denver Fire of such need; and

WHEREAS, Denver Fire has determined that it can assist Bomberos Voluntarios De San Pedro with the donation of firefighting equipment; and

WHEREAS, City and County of Denver and Denver Fire in recognition of its mission to promote fire safety donate surplus firefighting equipment to Bomberos Voluntarios De San Pedro; and

WHEREAS, the proposed donation of surplus firefighting equipment from the City and County of Denver to Bomberos Voluntarios De San Pedro cannot be made until approval by the Council of the City in accordance with subsection 2.9.3 (c), Part 9, of Article II of the Charter of the City; and

WHEREAS, the Director of General Services has determined that Denver Fire’s equipment is surplus and the donation is in the best interests of the City; and

WHEREAS the Mayor has duly reviewed and approved the proposed donation.

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. Subject to availability, the proposed donation of surplus firefighting to the Bomberos Voluntarios De San Pedro is hereby approved.
