8 **For an ordinance amending Ordinance 184, Series 1992, as amended by**
9 **Ordinance 1255, series of 2017, concerning the “Planned Fleet” Fund purpose.**

11 **WHEREAS**, Fund 11804 (formerly special fund 1191) was established by Ordinance No. 184,
12 Series of 1992 as the “Planned Fleet Replacement” Special Revenue Fund; and

13 **WHEREAS**, Ordinance 1255, Series of 2017 modified the fund name from the “Planned Fleet
14 Replacement Fund” to the “Planned Fleet Fund” and updated the scope to include new and
15 replacement vehicles and heavy equipment; and

16 **WHEREAS**, the Department of Finance (DOF) desires to amend the eligible uses of the fund
17 to include costs that improve fleet equipment availability, including but not limited to purchasing
18 parts, outsourcing for repairs, and labor for maintenance; and

19 **WHEREAS**, the Department of Transportation and Infrastructure will work with the DOF to
20 determine how much of the fund’s capacity will be used towards towards said expenses; and

21 **WHEREAS**, this request is a companion to the annual Long Bill and allows for an
22 administrative action needed to implement the 2026 budget as adopted;

25 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**
26 **DENVER:**

27 **Section 1.** That Sections 3 is hereby amended to read as follows:

28 “Section 3. Expenditures include the purchase of new and replacement
29 vehicles, ~~and heavy equipment, and costs that improve fleet equipment availability.~~

30 Expenditures are authorized in Accounting No. 11804, in the amount not to exceed
31 the total of deposits described in Section 2 of this Ordinance, to be expended by the
32 Executive Director of The Department of Transportation and Infrastructure ~~Public~~

33 ~~Works~~. This is a cash basis, non-lapsing fund.”

Section 2. The Chief Financial Officer of the City and County of Denver is hereby authorized and directed to make such book and record entries and to do such other things as may be necessary to accomplish the purposes of this Ordinance.
