A RESOLUTION

Of City Council sitting as the ex officio Board of Directors of the Denver 14th Street General Improvement District to approve the 2026 Work Plan and 2026 Budget, including the Capital Charges and 2026 Maintenance Charges, and making appropriations for the 2026 Fiscal Year, and amending the 2025 Budget.

WHEREAS, the Denver 14th Street General Improvement District (the “District”) was created by Denver Ordinance No. 464, Series of 2009, (“Creation Ordinance”) and said Creation Ordinance recognized the Council of the City and County of Denver as the Board of Directors of the District (the “Board of Directors”), pursuant to C.R.S. 31-25-609, C.R.S.; and,

WHEREAS, the Board of Directors is authorized to approve the Work Plan and Budget and impose Capital Charges and Maintenance Charges; and,

WHEREAS, Denver Ordinance No. 463, Series of 2009, established a District Advisory Board (the “Advisory Board”) for the District, and specified that such Advisory Board should, subject to the approval of the Board of Directors, conduct and manage certain affairs of the District as the authorized agent of the Board of Directors including certain financial and legal affairs; and

WHEREAS, the said Ordinance No. 463, Series of 2009, also calls for the Advisory Board to prepare, hold a public hearing on, deliver and recommend to the Board of Directors, at least once a year, a Work Plan, Budget, Capital Charges, and Maintenance Charges (as such terms are defined in the Creation Ordinance) for the next succeeding fiscal year; and,

WHEREAS, following due notice, the Advisory Board held a public hearing on September 23, 2025, on the proposed Capital Charges, Maintenance Charges, Work Plan and Budget, and has prepared, delivered and recommended to the Board of Directors for its approval of the District Work Plan, Budget, Capital Charges, and Maintenance Charges for the 2026 Fiscal Year; and

WHEREAS, in an election held on November 3, 2009, the eligible electors of the District approved ballot issues authorizing the creation of the District, and the collection, retention and spending of revenues in the amounts not less than as specified in the proposed 2026 Work Plan and Budget.

1 **NOW, THEREFORE, AFTER HOLDING A PUBLIC HEARING IN ACCORDANCE WITH**
2 **PUBLICATION, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER,**
3 **IN ITS EX OFFICIO CAPACITY AS THE BOARD OF DIRECTORS OF THE DENVER 14TH**
4 **STREET GENERAL IMPROVEMENT DISTRICT:**

6 **Section 1.** That the 2026 Work Plan and Budget for the District as filed in the Office of the
7 City Clerk, ex-officio Secretary of the District, in File No. 2009-0629-AJ, be and hereby are adopted
8 and approved.

9 **Section 2.** The sum of money identified for each fund in the 2026 Budget for expenditure in
10 the 2026 Fiscal Year is hereby appropriated for such purpose.

11 **Section 3.** That the Capital Charges and Maintenance Charges set forth in the schedules
12 filed with the Office of the City Clerk, ex-officio Secretary of the District, are hereby imposed on each
13 property within the District boundaries and such amount of money, being necessary to be raised
14 from Capital Charges and Maintenance Charges for the purpose of the District's expenses as set
15 forth in the 2026 Budget, is hereby approved.

16 **Section 4.** That the fiscal year of the District shall begin on the first day of January and end
17 on the last day of December each year.

18 **Section 5.** That the amended 2025 Budget for the District as filed in the Office of the City Clerk,
19 ex officio Secretary of the Board of Directors of the District, in File No. 2009-0629-AJ, be and hereby is
20 adopted and approved.

21 **Section 6.** That the City Clerk of the City and County of Denver, acting ex officio as the
22 Secretary of the Board of Directors of the District, shall attest and affix the seal of the District to this
23 Resolution.

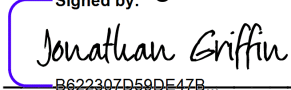
