This is a contract with Denver Public Schools to install 110.4 kW of solar via 11 outdoor classroom solar canopies across 11 Denver Public School locations. Denver's Solar Outdoor Learning Incentive Program advances Denver's goal to reach 100% renewable energy by 2030, while prioritizing public health, workforce development, and youth engagement. Denver Public Schools is investing in student physical and emotional well-being by providing engaging outdoor learning environments. These outdoor learning spaces will be enhanced through addition of solar shade structures.

The solar outdoor learning spaces reduce greenhouse gas emissions, increase the resilience of Denver's energy systems, and lower utility costs for schools. The program strives to inspire the next generation of climate leaders through collaborative programming related to clean energy curriculum and lesson plans, career exposure, and other student-oriented activities.
