This is a Grant IGA with Colorado Department of Transportation (CDOT) to provide funding for new 10 foot multi-use trail and two trail underpasses, with one under Colorado Boulevard and the other under Hampden Avenue.

This IGA allows for the transfer of \$4,050,000.00 in Federal funding to the City and County of Denver for design and construction of the referenced project. Only the Design funds are currently available, with the Construction funding becoming available upon Federal authorization and execution of either an Option Letter (Exhibit D) or Amendment. The Design funds total \$1,000,000.00. Total IGA is \$5,062,500 (Fed funds = \$4,050,000.00; local match of \$1,112,500.00).
