#### **Business Development**

## CB15-0811 A bill for an ordinance adopting a new Article XII in Chapter 10 of the Denver Revised Municipal Code, concerning construction defect claims in common interest communities.

Amends the Denver Revised Municipal Code by adding a new Article XII to Chapter 10 concerning construction defect claims in common interest communities. Amended 11-23-15 to require majority consent of unit owners before the executive board of a homeowners association may file a construction defect claim. The ordinance does not, and is not intended to, permit or require any greater percentage than a simple majority of unit owners to authorize such a claim. Deleting the words "at least" will eliminate any possible implication that a percentage greater than a simple majority of unit owners may be required in order for the executive board to bring a construction defect claim in any particular common interest community created in Denver in the future. The amendment also corrects a typographical error in the way the subsections are lettered on page 7 of the bill. The Committee approved filing this bill at its meeting on 10-27-15.

## CB15-0829 A bill for an ordinance to appropriate the 2015 Revenue Based Winter Park Parks and Recreation Capital Fund.

Appropriates \$764,271 to the Winter Park Parks and Recreation Capital Fund for the capital repair and rehabilitation of existing park and recreation facilities due to receipt of 2015 revenue based annual payment per the terms of the existing Winter Park Lease and Operating Agreement. The Committee approved filing this bill at its meeting on 11-3-15.

## CB15-0830 A bill for an ordinance making appropriations from the State Conservation Trust Fund for the purchase of land from Xcel Energy.

Appropriates \$50,000 from State Conservation Trust Fund contingency to support the acquisition of two parcels that have been decommissioned by Xcel Energy at Irving and Kentucky in District 3 and at 29th and Fairfax in District 8 for use as open space. The Committee approved filing this bill at its meeting on 11-3-15.

## CB15-0839 A bill for an ordinance making appropriations to pay the expenses of conducting the public business for the year 2016 and for the purposes required by the Charter and by other law.

Approves the 2016 Annual Appropriation Ordinance (Long Bill). The Committee approved filing this bill by consent on 11-5-15.

# CB15-0840 A bill for an ordinance re-naming an "Alternative Fuel Station" fund in the Public Health Special Revenue Fund and the means for collecting revenues and authorizing expenditures from such fund.

Renames Fund 14601 from "Alternative Fuel Station" to "Health Private and Other Grants" to reflect a broadened purpose. The Committee approved filing this bill by consent on 11-5-15.

CB15-0841 A bill for an ordinance establishing a "Police/Fire Pension" fund in the Public Safety Special Revenue Fund and the means for collecting revenue and authorizing expenditures from such fund. Establishes a Police and Fire Pension Special Revenue Fund to handle funds for the Police and Fire pensions programs. The Committee approved filing this bill by consent on 11-5-15.

#### **Infrastructure & Culture**

CB15-0831 A bill for an ordinance amending the legal description in Ordinance No. 15-0354, Series of 2015 to vacate a portion of the right-of-way between 2345 7th Street and 695 Water Street, with reservations. Amends a vacating ordinance (Ordinance 15-0354, Series of 2015) to include a corrected legal description of 695 Water Street in Council District 1. The Committee approved filing this bill by consent on 11-5-15.
