The purpose of the contract is to establish an agreement and Scope of Work between Denver Human Services (DHS) and Mile High Montessori Early Learning Centers (MHM) d.b.a. Mile High Early Learning (MHEL). Under this agreement MHM will provide drop-in, short term child care at the Good Beginnings Child Care Center (GBCCC) while parents are engaged in various TANF related activities at DHS. The center is located on-site on the first floor of the Richard T. Castro Human Services building, 1200 Federal Blvd., Denver, Colorado 80204.

1. Approximately 3,500 – 4,500 children will receive care at the GBCCC throughout the term of this agreement.
2. A minimum of 8,000 individual teacher/child contact hours will be provided at GBCCC throughout the term of this agreement.
