Dear Honorable Members of City Council,

Thank you for the opportunity to share my support for the renewal of the RiNo Business Improvement District (BID). My name is Diana Merkel—former BID Chair, long-time resident, property owner, and practicing artist in RiNo since 2006. What follows is a summary of my experience on the BID Board, some reflections on its evolution, and a personal example of how its programs have made a meaningful impact. I hope these insights are helpful as you consider the BID's renewal.

I joined the RiNo BID Board in 2019, bringing with me the perspective of both an artist and property owner. It was a valuable opportunity to engage in meaningful work alongside long-standing stakeholders, and to collaborate with RiNo staff, boards, and the City on initiatives such as the installation of stop signs and the conversion of Walnut Street to a two-way corridor. We also focused on affordability, support for artists and small businesses, and projects like the RiNo Art Park, No Vacancy, and the Studios on Blake. During this time, we developed a Strategic Plan to guide future leadership as Tracy Weil stepped down from his role as Executive Director.

When the pandemic began, I moved into the role of BID Chair. It was an exceptionally challenging period marked by leadership transitions, the shift to virtual meetings, and the cancellation of key events. Rebuilding in the aftermath has taken considerable effort. RiNo staff and all district board chairs (BID, GID, KRW, RAD) dedicated countless hours to revisiting finances, re-establishing governance processes, recruiting new board members, surveying the community, and working closely with the Executive Committee.

Today, I feel the work has paid off, and the BID has never been more ready to take on the next ten years of vital infrastructure and cultural initiatives. Under the leadership of new BID Chair Adam Larkey, and with the support of external consultants, the organization is thoughtfully refining its structure and re-engaging with stakeholders in meaningful ways. The current board is a compassionate, capable and diverse group, deeply committed to sustaining a vibrant and inclusive Art District.

As RiNo continues to grow, so do the scale and complexity of its challenges and opportunities. A strong arts culture has long been a driver of place-making, economic vitality, and community identity. The BID's renewal assures that can continue.

On a personal note, the BID's and Art District's support has enabled me to transition from running a small branding shop to becoming a nationally recognized installation artist. Programs like No Vacancy and Art RiNo gave me the space to experiment, develop my practice, and shape a new career trajectory. I know I'm not the only artist being impacted in this way by district initiatives. Having a seat at the table next to developers, small business owners, and district leadership came with its challenges, but I have grown so much over my time on the board and feel like I now have a voice in the community. We should celebrate wins like this, and use it to fuel our work going forward. Thank you for your ongoing support of RiNo, The BID, and of the role arts and culture play in Denver's continued evolution.

RiNo Art District has had an incredibly positive impact on my practice, to the point that without it I'm not sure I would have any exposure in the neighborhood. They are the reason we have First Fridays and are able to connect with the community, bring them into our studios, and show them our art. I have gotten multiple gallery shows and commissions simply from people looking through the RiNo directory of artists and finding me. The outreach and community engagement they foster is what makes RiNo an art district. Without their continued support the artists in RiNo will disappear, not because we will go away, but because we won't have an organization actively keeping us visible in the community. An arts community in a business oriented neighborhood doesn't happen organically, it requires intentional organization which they provide. Without the BID, I don't believe RiNo will continue to be known for arts, it will become just another gentrified city neighborhood without an art culture and no identity unifying the community.
