8 **A resolution extending the declaration of local disaster emergency pertaining**
9 **to COVID-19, influenza, and respiratory syncytial virus filed with the clerk and**
10 **recorder to February 27, 2023.**

11
12 **WHEREAS**, this emergency declaration is consistent with the Governor of Colorado's
13 COVID-19 and Other Respiratory Illnesses Disaster Recovery Order ("D2022 045");

14 **WHEREAS**, the threats posed by COVID-19, influenza and respiratory syncytial virus
15 ("RSV") continue to require emergency action and resources to avert danger or damage and to
16 protect public health;

17 **WHEREAS**, on January 4, 2023, Mayor Hancock filed with the City and County of Denver
18 Clerk and Recorder, a State of Local Disaster Emergency Declaration (hereinafter "Declaration");

19 **WHEREAS**, the period of Declaration is currently in effect until Wednesday, January 11,
20 2023;

21 **WHEREAS**, pursuant to state law, Colo. Rev. Stat. §24-33.5-709(1), the effect of the period
22 of local disaster cannot exceed seven days except by or with the approval of City Council;

23 **WHEREAS**, out of an abundance of caution, City Council intends to further extend the
24 current declaration until Monday, February 27, 2023;

25 **WHEREAS**, this emergency declaration is necessary for the City to continue to receive
26 federal public assistance funds for emergency protective measures; and

27 **WHEREAS**, the emergency declaration gives the City the ability to expedite procurement for
28 critical services that provide shelter for people in need and purchase protective equipment for
29 Denver's essential workers, among other time-sensitive needs.

31 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

32 **Section 1.** That the State of Local Disaster Emergency Declaration prepared by Mayor
33 Michael B. Hancock and filed with the Clerk and Recorder of the City and County of Denver on
34 January 4, 2023, be extended until February 27, 2023, and shall be in effect until terminated by the
35 Mayor or by City Council in accordance with state and local laws.
