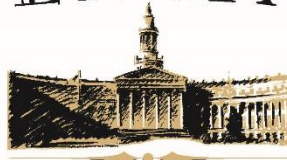


PROCLAMATION



City and County of Denver

Proclamation No. 17-0993

Honoring the Board of Directors of the Denver Union Station Project Authority for its Service

WHEREAS, the Denver Union Station Project Authority (“DUSPA”) is a Colorado nonprofit corporation and instrumentality of the City created pursuant to Ordinance No. 334, Series of 2008, adopted by the City Council of the City on June 30, 2008, and was created for the purposes of financing, equipping, designing, constructing, renovating, and taking such other action as necessary with respect to the redevelopment of Denver Union Station; and

WHEREAS, since its formation, DUSPA has operated as a partnership among the City, the Regional Transportation District (“RTD”), the Colorado Department of Transportation, the Denver Regional Council of Governments, and the Denver Union Station Metropolitan District (collectively, the “Partner Organizations”); and

WHEREAS, since its formation, DUSPA has been managed and controlled by a board of directors comprised of thirteen appointees representing each of the Partner Organizations (the “Board”); and

WHEREAS, over the past nine years, the following individuals have served on the Board, generously donating their time and effort to steward the redevelopment of Denver Union Station:
