 WHENCE THE SOUTH SIXTEENTH CORNER OF SAID SECTION 31, MONUMENTED WITH A 1 1/2" ALUMINUM CAP (ILLEGIBLE) BEARS N 0°22'23" W (BASIS OF BEARINGS - ASSUMED) A DISTANCE OF 1320.05 FEET;  
 THENCE N 0°22'23" W ALONG THE WEST LINE OF SAID SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER (SW 1/4 OF SW 1/4) OF SECTION 31 A DISTANCE OF 399.98 FEET;  
 THENCE N 89°47'23" E DEPARTING SAID WEST LINE A DISTANCE OF 43.00 FEET TO A POINT ON THE NORTH LINE OF SAID LOT 7, SAID POINT BEING THE TRUE POINT OF BEGINNING;

THENCE N 89°47'23" E CONTINUING ALONG SAID NORTH LINE OF LOT 7 A DISTANCE OF 2.00 FEET;  
 THENCE S 0°22'23" E DEPARTING SAID NORTH LINE A DISTANCE OF 50.04 FEET TO A POINT ON THE SOUTH LINE OF SAID LOT 8;  
 THENCE S 89°47'23" W ALONG SAID SOUTH LINE A DISTANCE OF 2.00 FEET;  
 THENCE N 0°22'23" W DEPARTING SAID SOUTH LINE A DISTANCE OF 50.04 FEET THE TRUE POINT OF BEGINNING.
