This will be a "pass through" grant in partnership with the Bluff Lake Nature Center (BLNC). Due to GOCO eligibility requirements, BLNC must partner with the CCD for funding approval. DPR has applied to GOCO on their behalf and will pass the funds to BLNC via a second, separate sub-award contract. Due to increase of 50 % in site visits since 2019, there is a need for major infrastructure improvement.
