6. **General description of proposed ordinance including contract scope of work if applicable:**

The ordinance seeks to appropriate \$500,000 from the Winter Park Parks and Recreation Capital Fund contingency in the capital improvement program to support the completion of the Confluence Ramp Replacement and Plaza Restoration project. This funding will be used to support the rehabilitation of Shoemaker Plaza, specifically erosion control and bank stabilization along the S. Platte River as well as rehabilitation of the plaza structure and connectivity. \$1.8M in appropriated funding in the Environmental Services Enterprise Fund will be leveraged to address the environmental remediation required to complete the project. It is anticipated that an additional appropriation will be requested in the amount of \$750,000 for this project upon receipt of the 2016 Winter Park incentive payment.

This project meets the following justification for use of CIP contingency:

- Scope of work that cannot be reduced further or phased
- Unanticipated extraordinarily environmental remediation costs
- Federal funding via an executed IGA which obligates the City to project schedule milestones
- Project unable to be deferred until the next fiscal year as a result of a critical construction timeline and unanticipated conditions.
