**A BILL**

**For an ordinance making rescissions from and appropriations in Capital Improvement and Capital Maintenance Funds for shelter capital needs for asylum seekers coming into Denver from outside of the US border.**

**WHEREAS**, the City wishes to rescind savings from deferred and completed Capital Improvements and Capital Maintenance Fund projects; and

**WHEREAS**, said savings will support capital project needs related to shelter for asylum seekers coming into Denver from outside of the US border;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**
