This amendment to contract 201733020 will add \$500,000 in City funds for a new total of \$800,000 for the design and construction of a detention basin on the southwest corner of 49th & Grant on the property known as Platte Farm Open Space in the Globeville neighborhood. The detention basin is one component of a larger, Parks and Recreation led, brownfield to open space effort. The purpose of this project is to improve local drainage, mitigate flood risk, and integrate into the overall vision of the community park and open space. A future amendment to this IGA is anticipated in 2019 to add final UDFCD and Wastewater Enterprise monies to begin construction of the project.
