5 **A BILL**

6 **For an ordinance changing the zoning classification for 999 Jasmine Street in**  
7 **Montclair.**

8 **WHEREAS**, the City Council has determined, based on evidence and testimony presented  
9 at the public hearing, that the map amendment set forth below conforms with applicable City laws,  
10 is consistent with the City’s adopted plans, furthers the public health, safety and general welfare of  
11 the City, will result in regulations and restrictions that are uniform within the E-MX-3A district, is  
12 justified by one of the circumstances set forth in Section 12.4.10.8 of the Denver Zoning Code, and  
13 is consistent with the neighborhood context and the stated purpose and intent of the proposed zone  
14 district;

15 **NOW THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**  
16 **DENVER:**

17 **Section 1.** That upon consideration of a change in the zoning classification of the land area  
18 hereinafter described, Council finds:

- 19 a. The land area hereinafter described is presently classified as PUD 223.
- 20 b. It is proposed that the land area hereinafter described be changed to E-MX-3A.

21 **Section 2.** That the zoning classification of the land area in the City and County of Denver  
22 described as follows shall be and hereby is changed from PUD 223 to E-MX-3A:

23  
24 LOTS 27, 28, 29 AND 30, BLOCK 14, EXCEPT THE REAR OR WEST 8 FEET OF SAID  
25 LOTS, PORTER AND RAYMOND'S MONTCLAIR, AN ADDITION TO THE TOWN OF  
26 MONTCLAIR, CITY AND COUNTY OF DENVER, STATE OF COLORADO.

27  
28 in addition, thereto those portions of all abutting public rights-of-way, but only to the centerline  
29 thereof, which are immediately adjacent to the aforesaid specifically described area.

30 **Section 3.** That this ordinance shall be recorded by the Manager of Community Planning and  
31 Development in the real property records of the Denver County Clerk and Recorder.
