7 **For an ordinance amending Council Bill 17-0659 which named the City-owned**  
8 **building located at 2851 Tremont Place the Anna Jo Haynes Early Learning**  
9 **Center.**

10 **WHEREAS**, CB17-0659 previously named the City-owned property at 2851 Tremont Place  
11 the Anna Jo Haynes Early Learning Center and Ms. Garcia Haynes has requested that the name  
12 be corrected to the Anna Jo Garcia Haynes Early Learning Center; and

13 **WHEREAS**, both the underlying petition to name the building and CB17-0659 included the  
14 name Anna Jo Garcia Haynes in some places and the name Anna Jo Haynes in others;

15 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**  
16 **DENVER:**

17 **Section 1.** Section 1 of CB 17-0659 is hereby amended to read as follows: "That the City-  
18 owned property at 2851 Tremont Place shall henceforth be named the Anna Jo Garcia Haynes Early  
19 Learning Center."
