**A BILL**

**For an ordinance making an appropriation in the East Corridor Certification of Participation Fund to support the 2020 Wastewater Management Enterprise Fund portion of the East Corridor COP Payment.**

**WHEREAS**, in 2012, City Council approved an amendment through Ordinance No. 164, Series of 2012, to the Denver RTD FasTracks East Corridor and FasTracks East Corridor/Denver International Airport which stipulated that the City provide funding for additional capital improvements at two rail stations in the Gateway area and additional drainage capital improvements that were not contemplated by the original City/RTD agreements at the time; and

**WHEREAS**, to fund the additional improvements, the City entered into a Lease Purchase Agreement to execute and deliver the \$45 million Series 2012C1-C3 Certificates of Participation (Ordinance No. 240, Series 2012); and

**WHEREAS**, the 2012C1-C3 COPs have fixed annual level lease payments and are paid from “FASTER” funding received from the State designed for transportation improvements; and

**WHEREAS**, the annual lease payments are subject to annual appropriation by City Council, and are split between the Capital Improvement Fund and the Wastewater Management Enterprise Fund to properly account for expenditures; and

**WHEREAS**, the 2020 Long Bill includes a \$3,834,955 appropriation in the Capital Improvement Program for its portion of the lease payment, but omitted the \$875,460 appropriation in the Wastewater Enterprise Fund for its portion of the lease payment to achieve the full \$4,710,415 owed in 2020;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From the Wastewater Management Enterprise Fund, Accounting No. 72000, in addition to amounts heretofore appropriated by Ordinance No. 1193, Series of 2019, there is hereby

1 appropriated in 2020 to the appropriation accounts hereinafter designated the following amount of  
2 money, to be expended for the purposes and upon the authorizations in said Ordinance set forth:
