6 **For an ordinance amending Section 2-143 of the Revised Municipal Code**  
7 **concerning membership of community representatives to the Denver Head Start**  
8 **Policy Council.**

9 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

10 **Section 1.** Section 2-143.B.4.c., D.R.M.C. will be amended by deleting the language  
11 stricken and adding the language underlined to read as follows:

12 **“Sec. 2-143. - Governance of the office of children's affairs and program components.**

13 \* \* \*

14 c. *Community representatives.* Nine (9) members of the Denver great kids head  
15 start policy council shall be at large community representatives of the  
16 community served by Denver’s great kids head start program and may include  
17 parents of children who were formerly enrolled in Denver’s great kids head start  
18 program. ~~and shall be selected from the following categories:~~

- 19 ~~1. A person who shall be an experienced licensed pediatrician or a person~~  
20 ~~who shall have experience as a professional health care provider;~~
- 21 ~~2. A certified public accountant;~~
- 22 ~~3. An attorney;~~
- 23 ~~4. An individual who shall be experienced in early childhood education;~~
- 24 ~~5. An individual who shall be experienced in foundations or other charitable~~  
25 ~~award organizations;~~
- 26 ~~6. An individual who shall be experienced with the operation of nonprofit~~  
27 ~~organizations;~~
- 28 ~~7. A person who shall be experienced in business;~~
- 29 ~~8. A parent of a child formerly enrolled in Denver's head start programs;~~
- 30 ~~9. A person who shall be experienced in finance and/or the management of~~  
31 ~~money; and~~
- 32 ~~10. A person who shall be experienced in conducting fundraising for~~  
33 ~~nonprofit purposes.”~~

34 **Section 2.** Section 2-143.B.4.f., D.R.M.C. will be amended by deleting the language  
35 stricken and adding the language underlined to read as follows:

1 **"Sec. 2-143. - Governance of the office of children's affairs and program components.**

2 \* \* \*

3 f. *Terms/removal and vacancies.* The terms of the community representatives  
4 seated after the effective date of hereof shall be a maximum of ~~three (3)~~ five (5)  
5 one-year terms, in accordance with applicable federal law.

6 Upon notice from the policy council of a vacancy in the membership of the policy  
7 council, the director shall notify the appropriate appointing authority of such  
8 vacancy. The appropriate appointing authority shall then, in accordance with  
9 Subsection 2-143.B.4.d., nominate a new member to stand for election by the  
10 policy council to serve a maximum of ~~three (3)~~ five (5) one-year terms."
