**A BILL**

**For an ordinance making appropriations to the Golf Enterprise Fund.**

**WHEREAS**, the Golf Enterprise Capital Improvements Program seeks to increase appropriations due to a donation from the First Tee of Denver;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From the Golf Enterprise Fund, Accounting No. 79000, out of monies not otherwise appropriated and in addition to amounts heretofore appropriated by Ordinance No. 1237, Series of 2017, and any supplemental appropriations or rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the amount of money following such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:


The aforementioned appropriation will be used to construct a junior golf course at the Overland Golf Course.
