A BILL

For an ordinance amending Ordinance No. 1286, Series of 2021, concerning the “Dental Self-Insurance” Internal Service Fund.

WHEREAS, Ordinance 1286, Series of 2021, established the Dental Self-Insurance Internal Service Fund, No. 66200, to administer the City’s self-insurance program; and

WHEREAS, said Ordinance established that the Fund would be appropriated, and the Fund’s annual budget would be established in the Annual Appropriation Ordinance; and

WHEREAS, the City’s Medical and Dental Self-Insurance programs fund employee medical payments for participants who elect this benefit, and funds can only be used for this purpose; and

WHEREAS, the primary revenue to this Fund is City and employee premium contributions and is based on the number of employees participating in this plan; and

WHEREAS, Ordinance 1941, Series of 2023, amended the Medical Self-Insurance Fund, from appropriated to revenue-based to align the budget with program revenue received; and

WHEREAS, this Ordinance seeks to amend the Dental Self-Insurance Fund, from appropriated to revenue-based to align with the Medical Self-Insurance Internal Service Fund; and

WHEREAS, this request is a companion to the annual Long Bill and allows for an administrative action needed to implement the 2026 budget as adopted;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. Section 3 is hereby amended to read as follows:

“Section 3. Program expenditures are hereby authorized for the “Dental Self-Insurance” Fund, Accounting No. 66200 to be expended by the Personnel Director. Allowable expenses include dental claims payments to service providers and fees for claims services. This Fund is ~~appropriated~~ and lapsing revenue-based and non-lapsing.”
