Approves an amendment to the contract with Linebarger Goggan Blair & Sampson LLP, for professional legal and collection services, extending the contract two years through December 13, 2013, and adding \$200,000 to the contract cap amount (CE74041-1). CB11-0329 A bill for an ordinance establishing a "DHS Volunteer Services and Giving Donations Fund" program in the Human Services Special Revenue Fund and the means for authorizing expenditures from such fund. (GENERAL GOVERNMENT & FINANCE)

Creates a new special revenue fund to accept private donations and other revenue for the Denver Human Services Volunteer Services and Giving Programs to use the donations for the school supply, spring basket, and holiday gift drives. The Committee approved filing this bill by consent on 5-19-11.

CB11-0362 A bill for an ordinance authorizing the transfer of funds from the Convention Center Payments Special Revenue Fund to the Grant/Other Capital Projects Fund effective for calendar year 2011. (GENERAL GOVERNMENT & FINANCE)

Approves a cash transfer in the amount of \$250,000 from the Convention Center Payments Special Revenue Fund (Fund 15607) to the Entertainment Grant/Other Capital Projects Fund, and making an appropriation in the Grant/Other Capital Projects Fund for renovations of restaurant space at the Convention Center. The Committee approved filing this bill by consent on 5-19-11.

Health, Safety, Education & Services

CB10-1073 A bill for an ordinance amending Section 18-164 of the Revised Municipal Code, extending the military pay differential for eligible career service employees and members of the classified service through the end of calendar year 2011. (HEALTH, SAFETY, EDUCATION & SERVICES)

Extends the pay differential for civilian and sworn city personnel serving in Afghanistan and/or Iraq conflicts through December 31, 2011. The Committee approved filing this bill by consent on 12-2-10.

CB11-0335 A bill for an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and the United States of America concerning the "Shelter Plus Care Housing First Project FY11-12" program and the funding therefor. (HEALTH, SAFETY, EDUCATION & SERVICES)

Accepts a \$952,680 grant from the U.S. Department of Housing and Urban Development for Shelter Plus Care-Housing First to provide 102 units of tenant based rental assistance for chronically homeless individuals with mental illnesses. The Committee approved filing this bill by consent on 5-16-11.

CB11-0339 A bill for an ordinance approving and providing for the execution of a proposed grant agreement between the City and County of Denver and the United States of America concerning the "High Intensity Drug Trafficking Area (H.I.D.T.A.) FY11" program and the funding therefor. (HEALTH, SAFETY, EDUCATION & SERVICES)

Accepts a \$1,053,289 grant from the Office of National Drug Control Policy for the High Density Drug Trafficking Area FY2011 program. The last regularly scheduled Council meeting within the 30-day review period is on 6-27-11. The Committee approved filing this bill by consent on 5-16-11.

CB11-0361 A bill for an ordinance relating to Chapter 54 (Traffic Regulations), amending fees for parades. (HEALTH, SAFETY, EDUCATION & SERVICES)

Revises City Code provisions related to parade applications to add a third category to reduce police staffing, barricade requirements, and applicant costs for certain smaller parades as defined. The Committee approved filing this bill at its meeting on 5-17-11.

CB11-0368 A bill for an ordinance approving a proposed Amendatory Agreement between the City and County of Denver and the Guadalupe Project, Inc., to provide through the Core Services program direct intensive services that support and strengthen families who are at imminent risk of out-of-home placement and to increase the maximum contract amount for continued services. (HEALTH, SAFETY, EDUCATION & SERVICES)

Adds \$115,000 in state child welfare funds to the contract with Guadalupe Project, Inc. for a total contract of \$515,000 to provide services that support and

strengthen families who have children at imminent risk of out-of-home placement. The last regularly-scheduled Council meeting within the 30-day review period is on 6-27-11. The Committee approved filing this bill by consent on 5-26-11.

CB11-0369 A bill for an ordinance approving a proposed Amendatory Agreement between the City and County of Denver and Savio House, to provide (through the Core Services program) direct intensive services that support and strengthen families who are at imminent risk of out-of-home placement and to increase the maximum contract amount for continued services. (HEALTH, SAFETY, EDUCATION & SERVICES)

Adds \$150,000 in state child welfare funds to the contract with Savio House for a total contract of \$1,107,000 provide services that support and strengthen families who have children at imminent risk of out-of-home placement. The last regularly scheduled Council meeting within the 30-day review period is on 6-27-11. The Committee approved filing this bill by consent on 5-26-11.

Land Use, Transportation & Infrastructure

CB11-0309 A bill for an ordinance approving an agreement between ECI Site Construction Management, Inc. and the City and County of Denver for Berkeley Park Improvements. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Approves a \$2,331,414.37 contract with ECI Site Construction Management for the Berkeley Park Improvements, a Better Denver Bond Project in Council District 1. The last regularly scheduled Council meeting within the 30-day review period is on 6-27-11. The Committee approved filing this bill by consent on 5-5-11.

CB11-0321 A bill for an ordinance authorizing the issuance of City and County of Denver, Colorado, General Obligation Better Denver Bonds, Series 2011A, for the purpose of financing and/or refinancing and defraying the cost of acquiring, constructing, installing and improving various civic facilities, together with all necessary, incidental or appurtenant properties, facilities, equipment and costs; providing for the levy of general ad valorem taxes to pay the principal of and interest on the Series 2011A Bonds; authorizing the execution of certain agreements and providing other details in connection therewith; ratifying action previously taken relating thereto; providing other matters relating thereto; and making other provisions relating thereto. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Authorizes issuance of up to \$20 million of fixed rate, tax-exempt general obligation bonds as part of the Better Denver Bond Program authorized by voters in 2007, to fund identified projects. The Committee approved filing this bill by consent on 5-12-11.

CB11-0337 A bill for an ordinance approving an amendatory agreement between Carnation Building Services, Inc. and the City and County of Denver to increase compensation. (LAND USE, TRANSPORTATION &

INFRASTRUCTURE)

Amends the agreement with Carnation Building Services, Inc. to increase compensation by \$150,000, for a new total of \$600,000, needed for continuation of custodial services through the end of the contract term, Dec. 31, 2011, and to allow the City to add or delete services as needed, in part due to opening the Stapleton Central Park Recreation Center. The last regularly scheduled Council meeting within the 30-day review period is on 6-27-11. The Committee approved filing this bill by consent on 5-19-11.

CB11-0341 A bill for an ordinance approving an agreement between Regional Transportation District and the City and County of Denver for the design and construction of the FasTracks Gold / NWES Corridor. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Approves an Intergovernmental Agreement with RTD for the FasTracks Gold Line to Arvada, applying the City's overmatch funds from the West Corridor to the Gold Line. The last regularly scheduled Council meeting within the 30-day review period is on 6-27-11. The Committee approved filing this bill by consent on 5-26-11.

CB11-0343 A bill for an ordinance approving a second amendatory on-call agreement between Interlock Construction Corporation and the City and County of Denver that will provide general construction services. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Amends the on-call construction services contract with Interlock to extend the term two years to June 1, 2013, to utilize the total \$8 million capacity. The last regularly scheduled Council meeting within the 30-day review period is 6-27-11. Committee approved filing this bill by consent on 5-19-11.

CB11-0345 A bill for an ordinance approving a second amendatory on-call agreement between Turner Construction Company and the City and County of Denver to extend the term for general construction services. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Approves a no-cost, two-year extension of the term of the on-call construction services contract with Turner Construction Co. to June 1, 2013. The last regularly scheduled Council meeting within the 30-day review period is on 6-27-11. The Committee approved filing this bill by consent on 5-19-11.

CB11-0349 A bill for an ordinance approving a third amendatory agreement between the City and County of Denver and URS Corporation for construction services to widen East 56th Avenue between Quebec and Havana Streets in Council District 11. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Adds \$660,000, for a new total of \$3,794,514, to the URS Corporation contract to provide construction support services for construction of 56th Ave. between Quebec and Havana in Council District 11. The last regularly scheduled Council meeting within the 30-day review period is on 6-27-11. The Committee approved filing this bill by consent on 5-19-11.

CB11-0350 A bill for an ordinance approving an amendatory on-call agreement between Jacobs Investments, LLC d/b/a Colorado Boring Co. and the City and County of Denver for the 2011 On Call Directional Boring Project. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Amends the on-call contract with Colorado Boring Company to extend the term one year and add \$500,000, for a new total of \$1,200,000. The last regularly scheduled Council meeting within the 30-day review period is on 6-27-11. The Committee approved filing this bill by consent on 5-19-11.

CB11-0360 A bill for an ordinance changing the zoning classification of 1601 Arapahoe Street. (LAND USE, TRANSPORTATION & INFRASTRUCTURE)

Makes a technical amendment to correct the official zoning map for property located at 1601 Arapahoe Street, the Daniels & Fisher Tower, changing the zoning classification from OS-A UO-1 to D-TD UO-1 in Council District 8. PUBLIC HEARING AT LEAST FOUR WEEKS FOLLOWING PUBLICATION. The Committee approved filing this bill by consent on 5-19-11.
