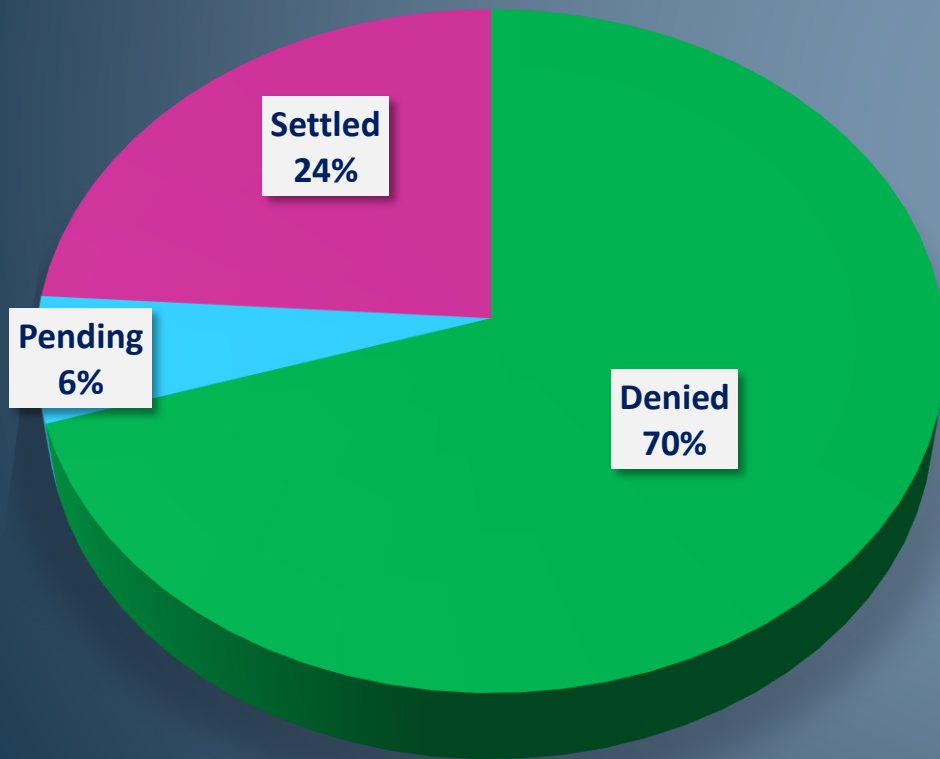

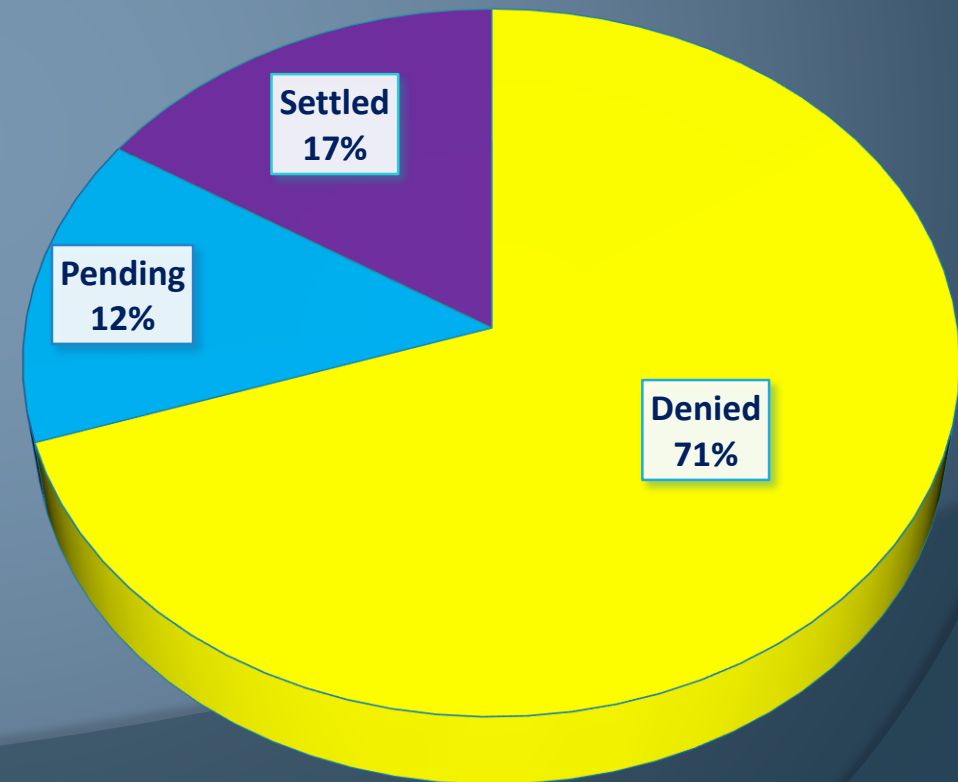

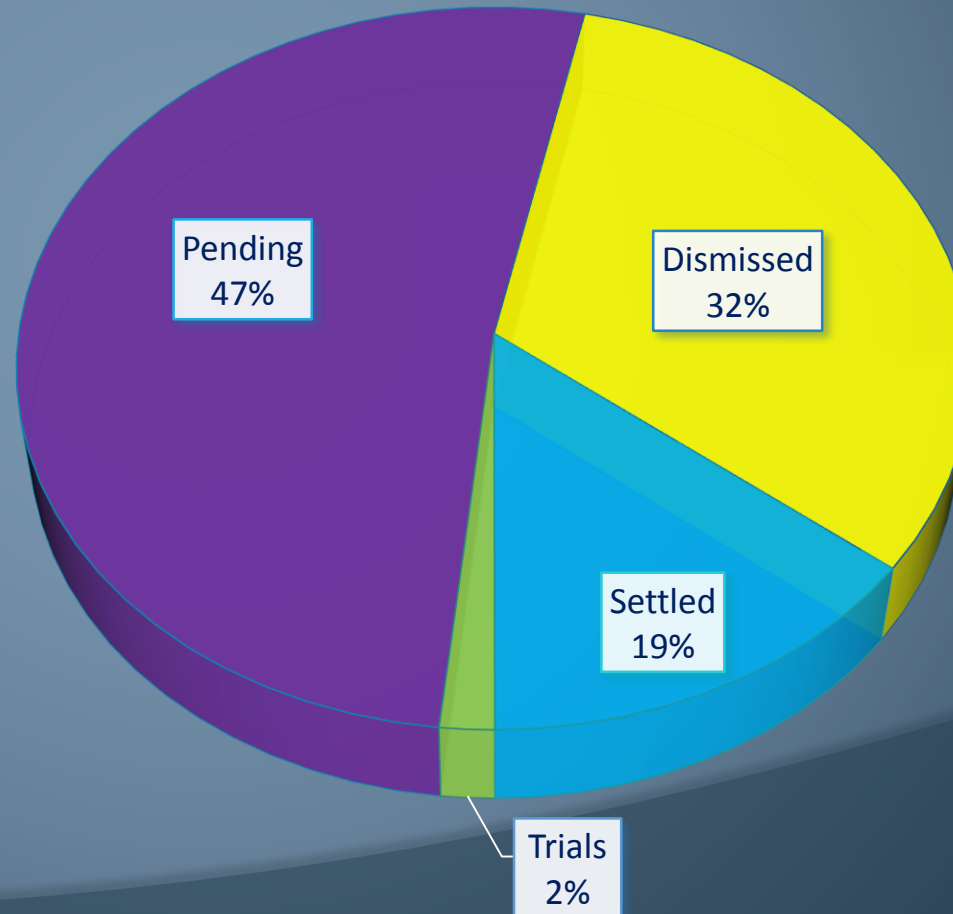

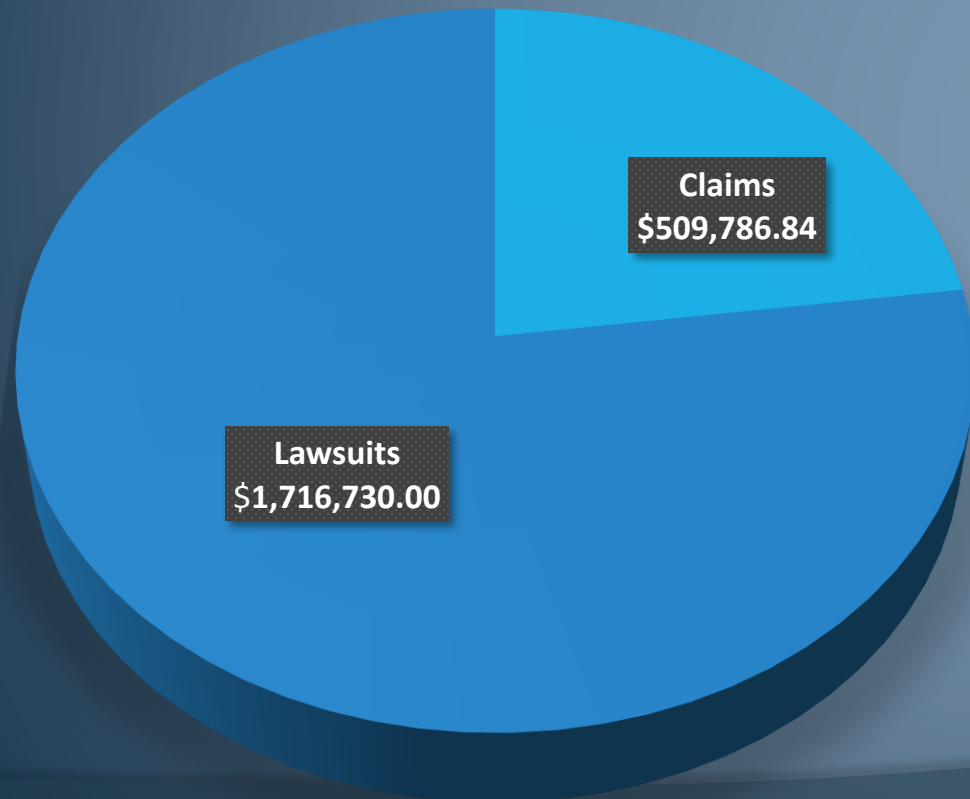

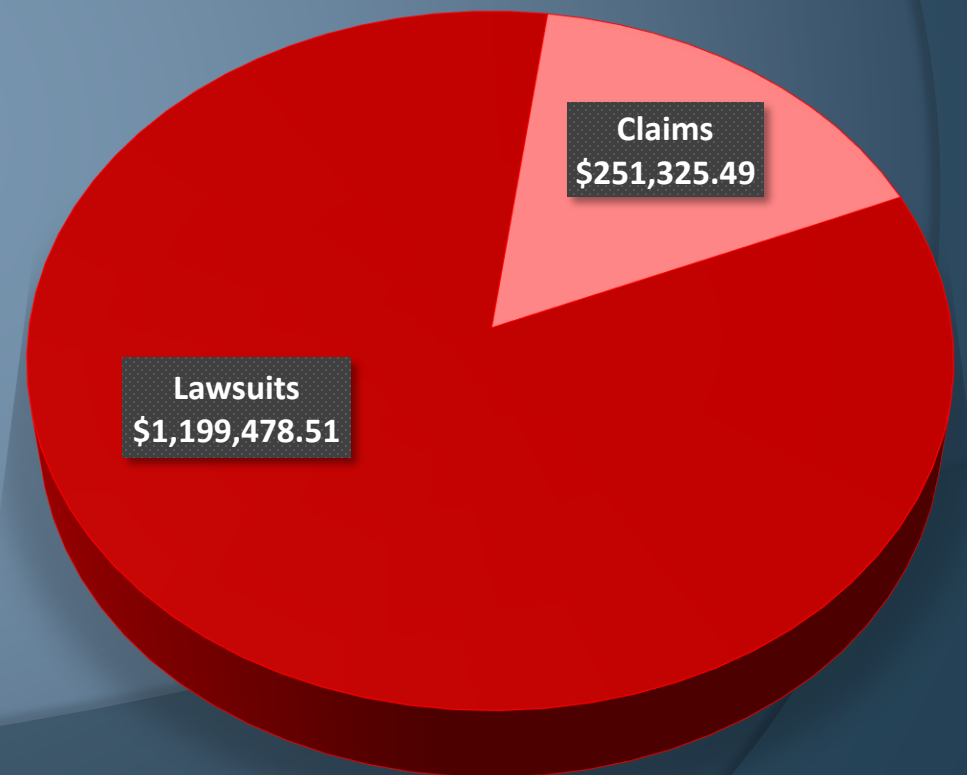

Safety Breakdown



2015

- ❖ 87 of the 112 lawsuits in 2015 were against Safety employees.
 - 29 cases were dismissed
 - 15 cases were settled in 2015 equaling \$1,366,530
 - Two cases were tried
 - 41 cases were pending

2016

- ❖ 83 of the 112 lawsuits in 2016 were against Safety employees.
 - 24 cases were dismissed
 - 10 cases were settled in 2016 equaling \$556,250
 - Two case were tried
 - 47 cases were pending

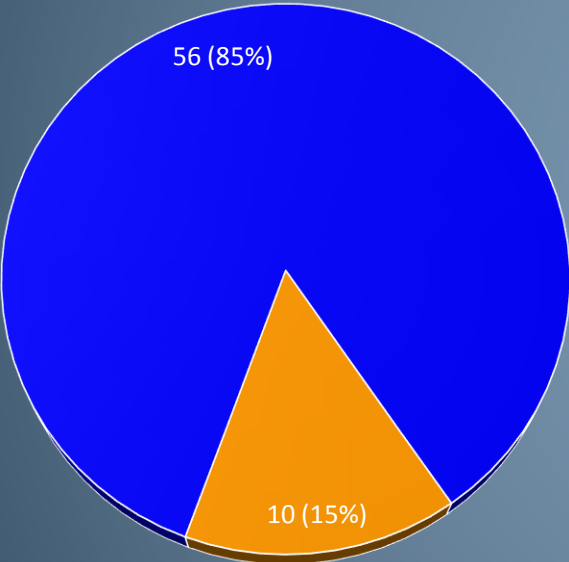

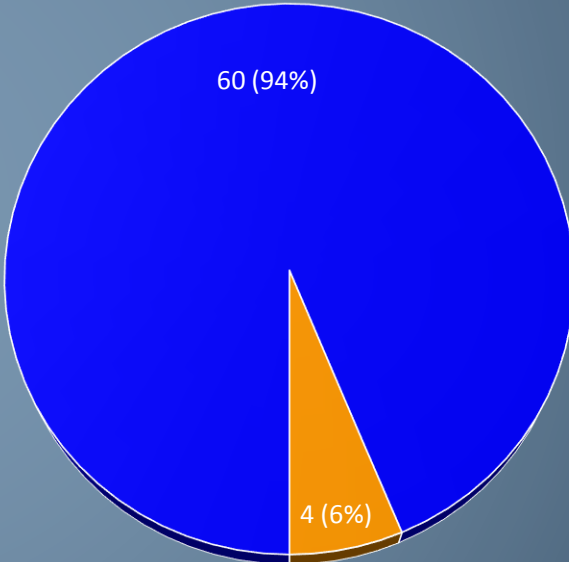

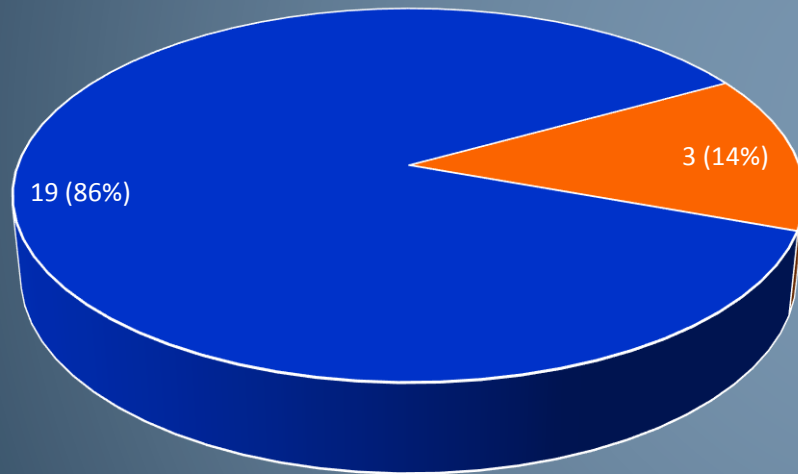

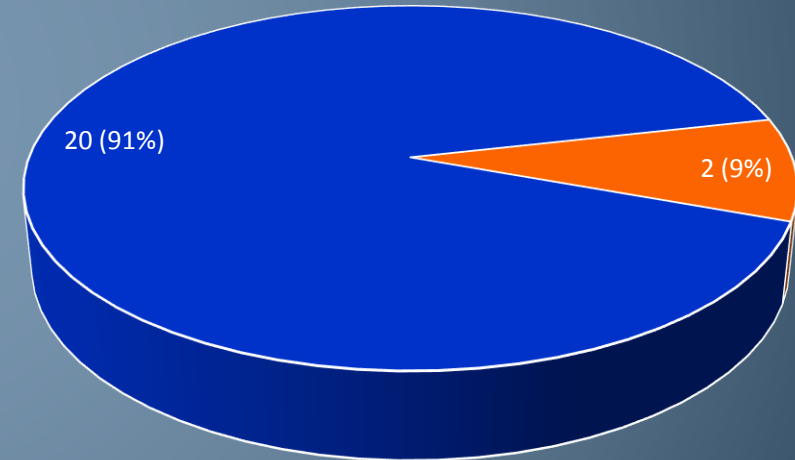

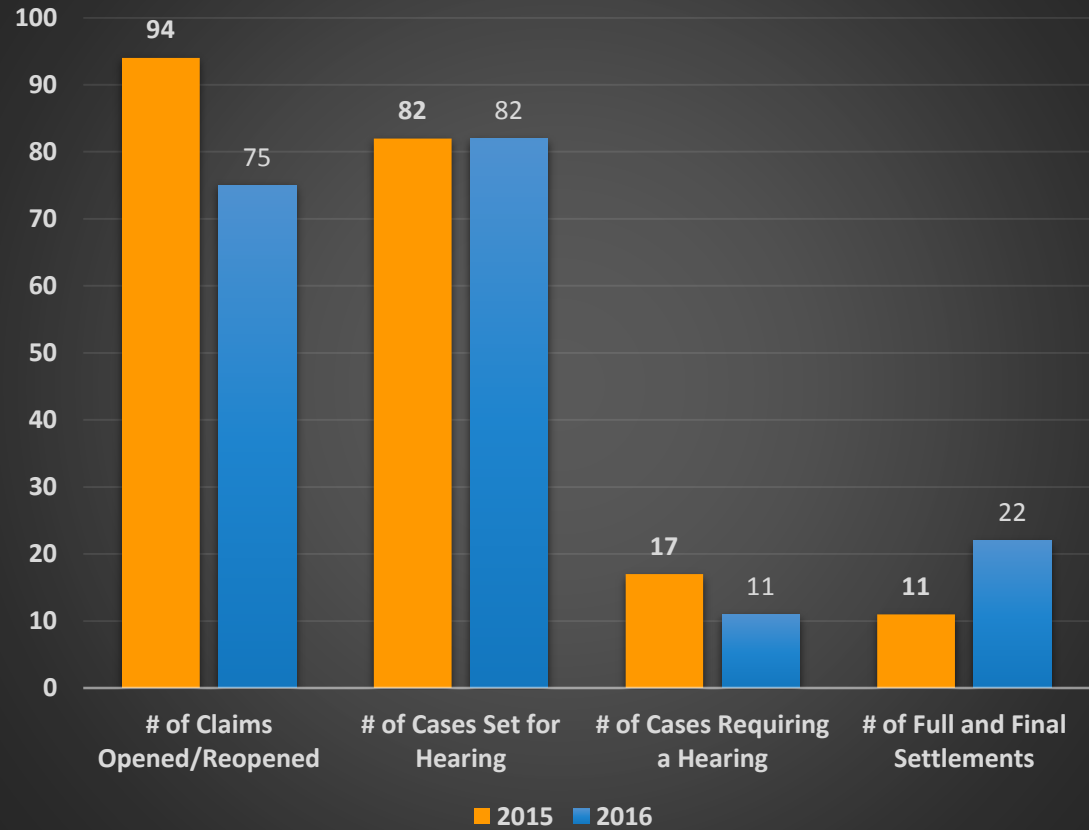

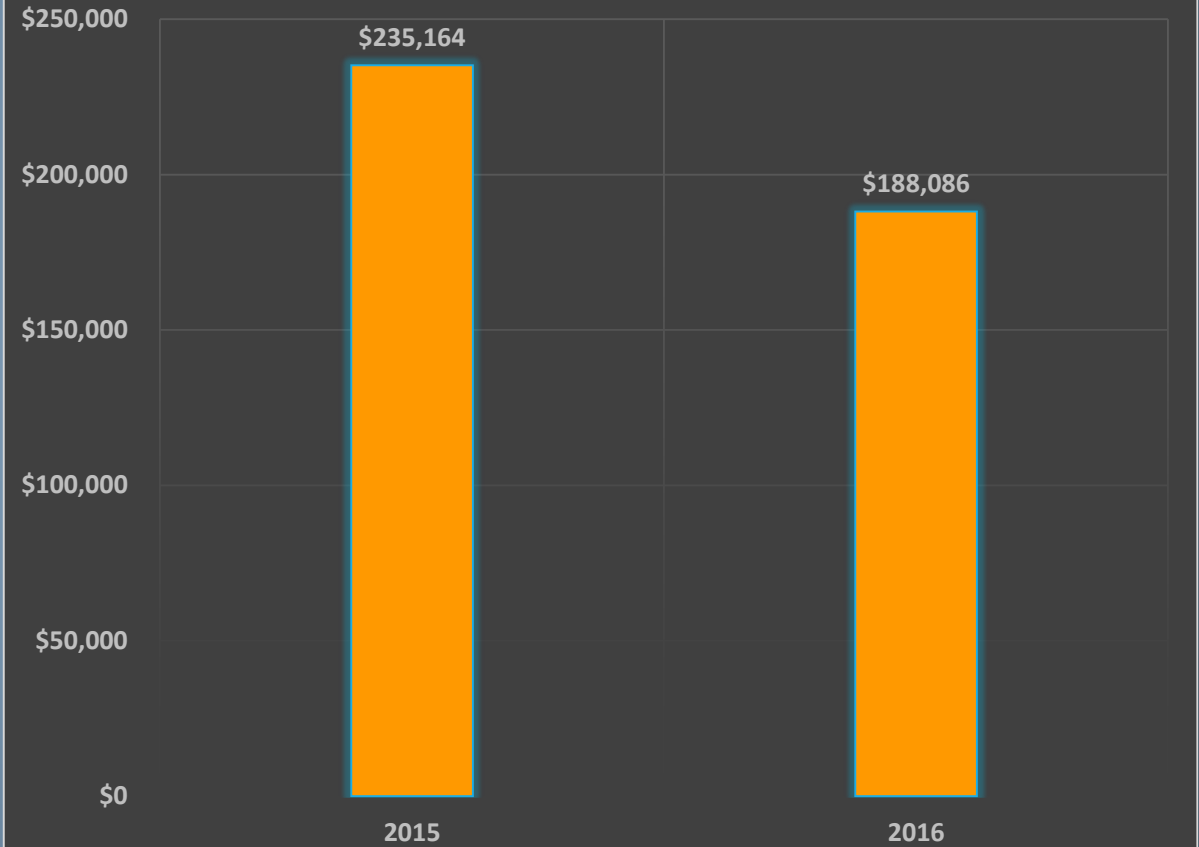

Cases Handled/Outcomes

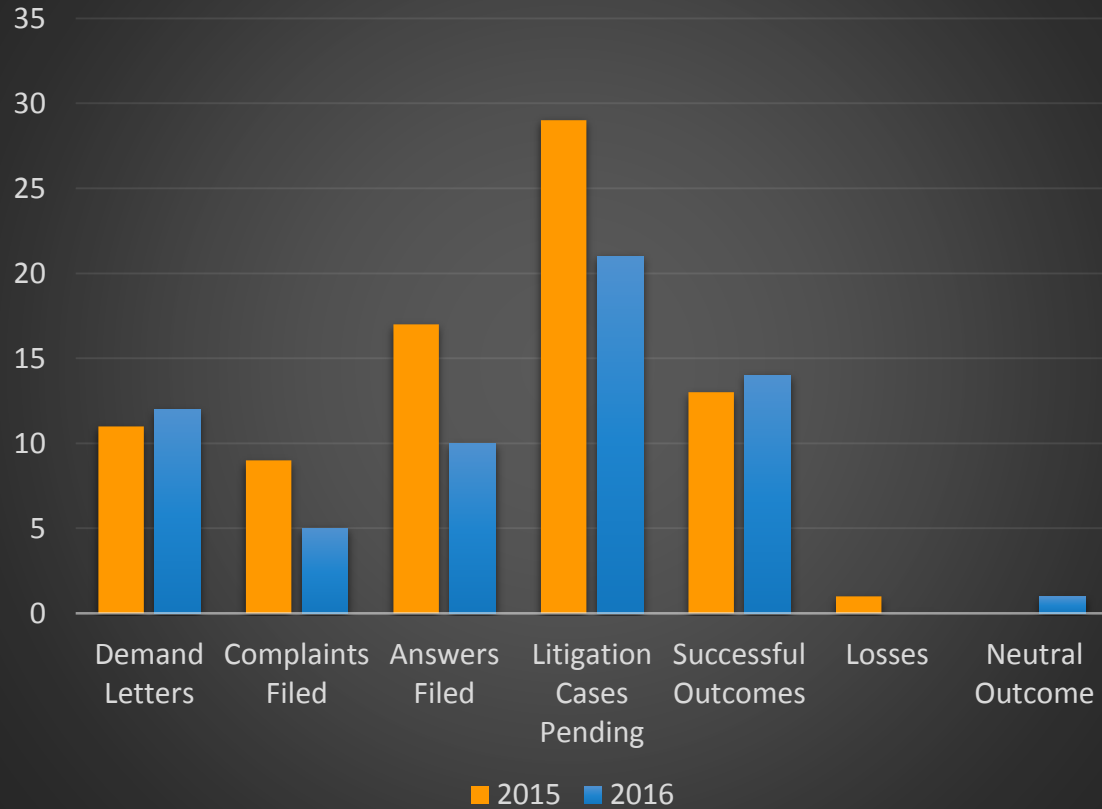


Amount Collected in Subrogation Cases
