Application Narrative

Consistent with Blueprint Denver goals, Community Planning and Development in partnership with the councilmembers, are leading the effort to implement adopted plans more efficiently through legislative rezonings. The Near Northwest Area Plan was adopted by the Denver City Council in January 2024 and outlines a vision for the neighborhoods of Chaffee Park, Sunnyside, Highland, and Jefferson Park. This project seeks to implement the Plan's guidance to ensure all properties have modern zoning standards and to improve the appearance and functionality of commercial and mixed-use areas.

The proposed rezoning implements two major themes found in the Near Northwest Area Plan. First, the rezoning implements goals and policies related to improving design standards in historic streetcar nodes and commercial corridors. Second, it brings most of the properties within the Near Northwest Area plan into the Denver Zoning Code, implementing plan goals to remove the old Former Chapter 59 zoning.

The improved design standards are focused in commercial areas along the historic streetcar line with a Blueprint Future Place designation of either "Corridor" or "Center". The commercial properties included are proposed to maintain the underlying mixed use and main street zone districts and add the Active Centers and Corridors Design Overlay (DO-8), which provides design standards that "encourage neighborhood mixed-use areas that support nonresidential active uses at the Street Level, promote active pedestrian-oriented building frontages, and provide sufficient space for transitions between the public realm and private residential Dwellings" (DZC Section 9.4.5.12.B.). The DO-8 requires a portion of the ground floor to be nonresidential active uses for wider lots, only allows the Shopfront and Townhouse building forms, and requires a two-foot primary street setback to encourage a pedestrian-friendly environment. The DO-8 fulfills much of the Near Northwest Area plan guidance related to improved design standards.

In addition, this part of the city has 49 instances of Former Chapter 59 zoning located throughout the plan area. The Near Northwest Area plan calls for these to be rezoned into the Denver Zoning Code to improve design standards and increase the predictability of development outcomes. This proposal has sought to match the entitlements provided by the current Former Chapter 59 zone district, while also implementing plan guidance.

Review Criteria

Consistency with Adopted Plans

The proposed official map amendment is consistent with the City's adopted plans, or the proposed rezoning is necessary to provide land for a community need that was not anticipated at the time of the adoption of the City's plan.

The proposed official map amendment is consistent with the City's adopted plans, as detailed below. The following adopted plans apply to this application:

- Denver Comprehensive Plan 2040
- Blueprint Denver
- Near Northwest Area Plan

Comprehensive Plan 2040

The proposed rezoning is consistent with the Denver Comprehensive Plan 2040. Some strategies that this legislative rezoning helps implement are listed below.

Vision Element: Equitable, Affordable, and Inclusive

- **Goal 1.** "Ensure all Denver residents have safe, convenient and affordable access to basic services and a variety of amenities" (p. 28).

The proposed map amendment will further the Comprehensive Plan 2040's Equitable, Affordable and Inclusive Goal to ensure all Denver residents have safe, convenient, and affordable access to basic services and a variety of amenities. The DO-8 requires nonresidential active uses on the ground floor, which promotes mixed-use developments with commercial on the first floor and residential above. This ensures any new residential constructed will also include services and amenities for new residents. In addition, the design standards in the proposed districts will promote greater walkability in the Near Northwest neighborhoods.

Vision Element: Strong and Authentic Neighborhoods

- **Goal 1, Strategy A.** "Build a network of well-connected, vibrant, mixed-use centers and corridors" (p. 34).
- **Goal 1, Strategy C.** "Ensure neighborhoods are safe, accessible and well-connected for all modes" (p. 34).
- **Goal 2, Strategy C.** "Create people-oriented places that embrace community character with thoughtful transitions, aspirational design and an engaging public realm" (p. 34).
- **Goal 2, Strategy D.** "Use urban design to contribute to economic viability, public health, safety, environmental well-being, neighborhood culture, and quality of life" (p. 34).

This proposed rezoning to include the Active Centers and Corridors Design Overlay (DO-8) is consistent with the abovementioned Strong and Authentic Neighborhoods goals to create people-oriented places that embrace community character with thoughtful transitions, aspirational design, and an engaging public realm. The proposed zone district's design standards for transparency, active uses, reduced visibility of parking and building entrance locations enable the creation of an active and human-scaled

experience at the street level. The application is consistent with the strategies in the Strong and Authentic Neighborhoods vision element.

Vision Element: Environmentally Resilient

- **Goal 8, Strategy A.** “Promote infill development where infrastructure and services are already in place” (p. 54).
- Goal 8, Strategy B. “Encourage mixed-use communities where residents can live, work and play in their own neighborhoods” (p.54)

The proposed legislative rezoning will promote high quality mixed-use development at infill locations where infrastructure is already in place. Portions of the requested rezoning areas currently have Former Chapter 59 zone districts and by rezoning out of Former Chapter 59 to a mixed use or main street zone district with the DO-8, the city is enabling mixed-use development with better design standards and a variety of uses which allow for residents to “live, work and play” in the same area, which reduces resource consumption.

Blueprint Denver

Blueprint Denver was adopted in 2019 as a supplement to *Comprehensive Plan 2040* and establishes an integrated framework for the city’s land use and transportation decisions. There are six key components of *Blueprint Denver* that apply to this rezoning proposal:

- Future neighborhood context
- Future places
- Street types
- Growth area strategy
- Plan policies and strategies
- Equity concepts

Future Neighborhood Context

In *Blueprint Denver*, future neighborhood contexts are used to help understand differences between land use, built form, and mobility, and to guide appropriate zone districts. The proposed legislative rezoning area includes several neighborhood contexts – Urban Edge, Urban, General Urban, Urban Center, and Districts.

Urban Edge Neighborhood Context. The Urban Edge context applies to properties in Chaffee Park along Federal and Pecos. *Blueprint Denver* describes the Urban Edge neighborhood context as areas that, “offer good walkability with short, predictable blocks. Many existing commercial developments in urban edge were established with the rise of the automobile and, as a result, are designed around single-occupancy vehicles. As these areas redevelop, they will be adapted to be more pedestrian-friendly, with buildings oriented to the public realm instead of parking lots” (p. 207).

The rezoning proposal to E-MX-3, DO-8 and E-MX-3A, DO-8 will implement the vision of the Urban Edge neighborhood context by applying zone districts that require nonresidential active uses on the ground floor and will encourage pedestrian-friendly frontages.

Urban Neighborhood Context. The Urban Context is mapped in Sunnyside, Highland, and a small portion of Jefferson Park. *Blueprint Denver* describes the Urban neighborhood context as “walkable due to a predictable street grid in residential areas and the availability of transit and dedicated bike lanes. These areas offer access to neighboring areas and commercial nodes, with some small mixed-use nodes within the neighborhood” (p. 221).

Rezoning to U-MX-3, DO-8, U-MS-3, DO-8, and U-MS-5, DO-8 along the centers and corridors will ensure the existing commercial nodes remain areas that provide amenities and services to the neighboring residents. Additionally, Former Chapter 59 properties mapped as the Urban context will be rezoned to U-TU-B, U-RH-2.5, U-RH-3A, U-MX-2x, U-MS-2x, U-MX-3, and U-RX-5.

General Urban Neighborhood Context. The General Urban Context is mapped in Jefferson Park, and *Blueprint Denver* describes this context as “vibrant places with proximity to Denver’s major centers like Downtown and Cherry Creek. Homes in this context vary from multi-unit complexes to compact single-unit homes. Development should be sensitive to the existing neighborhood character and offer residents a mix of uses, with good street activation and connectivity. Residents living in this context are well served by transit and enjoy access to abundant amenities and entertainment options” (p. 237).


The centers and corridors in these General Urban areas are proposed to be rezoned to G-MX-3, DO-8 and G-MS-3, DO-8. The proposed zone district will ensure these properties offer a mix of uses with good street activation consistent with the General Urban Context description. There are several Former Chapter 59 properties in this context, and they are proposed to be rezoned to G-MU-3, G-MX-3, and G-MS-5 (more information on the Former Chapter 59 existing zoning and proposed district can be found in the attachments).

Urban Center Neighborhood Context. The Urban Center context is mapped in the Diamond Hill area of Jefferson Park and the southside of I-25 in Highland. *Blueprint Denver* describes the Urban Center context as “dense and vibrant areas that support residents and visitors. This context contains high intensity residential and significant employment areas. Development typically contains a high mix of uses, with good street activation and connectivity. Residents living in this context are well served by high-capacity transit and have access to ample amenities and entertainment options” (p. 251).

The properties mapped as Urban Center in this rezoning package are proposed to be rezoned to C-MX-12, DO-8 and C-MX-5, DO-8. This will encourage a high mix of uses with good street activation and connectivity consistent with the context description.

Districts Neighborhood Context. *Blueprint Denver* identifies one property at 2060 N. Speer Blvd. as in the Districts context. This context is mapped in “areas that serve a specific purpose, usually highly specific based on uses, such as education, industry or health care. Block patterns, urban design and mobility connections vary based on specific use” (p. 137). This property is owned by Denver Public Schools and is adjacent to North High School. It’s currently zoned G-MX-3 and including the DO-8 will ensure any future development on the property will be pedestrian-oriented.

Future Places

The proposed rezoning contains properties in the following Future Places:

Centers. “Centers are mixed-use places of different scales. They are typically oriented around a shared space or set of spaces. People often go to centers to engage in social activities and entertainment, such as shopping, dining, and cultural events. Some centers are well-connected to the local neighborhood and supported by neighborhood residents; other centers are larger, attracting people from a wide geographic area, and may require residents to take a bus, train, or a car to visit them” (*Blueprint Denver*, p. 141).

Corridors. “Corridors are mixed-use places of different scales oriented along a street. They provide spaces for people to engage in social activities and entertainment, such as shopping and dining. Corridors are often embedded in neighborhoods and serve nearby residents” (*Blueprint Denver*, p. 141).

The proposed rezoning supports the center and corridor designations found in *Blueprint Denver*. These areas are proposed to be rezoned to a Mixed Use or Main Street zone district with the DO-8, which will encourage a mixed-use environment by requiring a portion of the ground floor be nonresidential active uses.


Residential. “These are areas where the predominate use is residential. Although they are primarily residential, they are supported by a variety of embedded uses needed for a complete neighborhood

including schools, recreation, and nodes of commercial/retail uses” (*Blueprint Denver*, p. 141). *Blueprint Denver* describes four different types of Residential Future Places, which denote the types of buildings and height generally found in different parts of the city. These types are Low Residential, Low-Medium Residential, High-Medium Residential, and High Residential. The proposed rezoning contains properties in the first three of these Future Places.

The residential districts included in this proposal are predominantly Former Chapter 59 zone districts. The proposed rezoning attempts to match the current entitlement allowed by the current district, while fitting with the vision described in *Blueprint Denver’s* Future Places.

Campus. Campus places have buildings that “vary greatly in size and form. Multi-story single-use and mixed-use building are typical...These areas are typically dominated by a single, large institutional user. Universities, medical centers and large research facilities are examples. Some supporting retail and residential uses may occur” (p. 291). The property with this designation is owned by Denver Public Schools and is adjacent to North High School. This property currently has an underlying zone district of G-MX-3 and including the DO-8 will ensure there are nonresidential active uses on the ground floor to support the surrounding campus.

Future Street Type

In *Blueprint Denver*, future street types of work in concert with future places to evaluate the appropriateness of the intensity of the adjacent development (p. 67). The three volume classifications of Local, Collector, and Arterial, are further refined by six types of surrounding context. The following Future Street Types are adjacent to the proposed legislative rezoning:

Main Street collectors and arterials. Main Streets are “characterized by a mix of uses including retail, services and restaurants, as well as residential. Buildings are pedestrian-oriented, with little front setback, a continuous street wall, and high transparency. Street level uses are highly activated, including cafe seating in the right-of-way” (p. 158).

Mixed-use collectors and arterials. “Varied mix of uses including retail, office, residential and restaurants. Buildings are pedestrian-oriented, typically multi-story, usually with high building coverage with a shallow front setback. A street wall is present, but may vary” (p. 159).

Residential collectors and arterials. “Primarily residential uses, but may also include schools, civic uses, parks, small retail nodes and other similar uses. Buildings on residential streets usually have a modest setback. The depth of the setback varies by neighborhood context” (p. 159).

Local Streets. “Local streets can vary in their land uses and are found in all neighborhood contexts. They are most often characterized by residential uses” (p. 161).

The proposed Mixed Use and Main Street districts with the DO-8 are mainly proposed along collector and arterial streets that are main street, mixed-use, and residential. While this district will require a portion of the ground floor to be nonresidential active uses, it also allows for a variety of commercial and residential uses consistent with the street type designations. The Former Chapter 59 zone districts are located along a variety of street types with commercial uses located more along arterials and collectors and lower scale residential along local streets.

Growth Area Strategy

Blueprint Denver's growth strategy map is a version of the future places map, showing the aspiration for distributing future growth in Denver (p. 51). The subject properties are part of the “community centers and corridors” and “all other areas of the city” growth areas.

Regional centers. These areas anticipate 50% of new employment growth and 30% of new housing growth in the city by 2040 (p. 51). The Regional Centers are mapped in Jefferson Park in the Diamond Hill and the area along Water St. south of I-25.

These areas are proposed to be rezoned to C-MX-12, DO-8. These are districts in the Urban Center context, which will promote the growth anticipate in these areas.

Community centers and corridors. These areas anticipate 20% of new employment growth and 25% of new housing growth in the city by 2040 (p. 51). Community Centers and Corridors are “where underutilized infill redevelopment sites can be repurposed” (p. 48-49). These areas are mapped in all four contexts, mostly along existing commercial corridors – Federal, 38th Ave., Speer, and Platte St.

The areas designated as community centers and corridors are proposed to be rezoned to a Main Street district with the DO-8. The proposed districts and the DO-8 will require new infill development include nonresidential active uses ensuring centers and corridors remain commercial corridors with services for

nearby residents. Therefore, the requested zone districts are consistent with the *Blueprint Denver* Growth Strategy.

All other areas of the city. These areas anticipate 10% of new employment growth and 20% of new housing growth in the city by 2040 (p. 51). These areas are intended to “take a smaller amount of growth intended to strengthen the existing character of our neighborhoods” (p. 49). Most of the Near Northwest is within the “all other areas of the city” growth strategy.

These areas include the rezoning of the centers and corridors and the Former Chapter 59 properties. The corresponding districts in the Denver Zoning Code will ensure that any new development is consistent with the existing character of the neighborhood.

Plan Policies and Strategies

Blueprint Denver contains numerous recommendations related to pedestrian-oriented design, promotion of housing, rezoning out of the Former Chapter 59 zoning code, and the arrangement of uses in mixed-use areas. The proposed rezoning is consistent with the following policies and strategies:

Land Use & Built Form, General Policy 3. “Ensure the Denver Zoning Code continues to respond to the needs of the city, while remaining modern and flexible” (p. 73).

- **Strategy A.** “Rezone properties from the Former Chapter 59 zoning code so that the entire city is covered by the DZC, including continuing to incentivize owners to come out of the old code” (p. 73).

The proposed legislative rezoning encompasses properties with Former Chapter 59 zoning that will be rezoned to standard zone districts in the Denver Zone Code and are consistent with *Blueprint Denver*.

Land Use and Built Form, General Policy 11. “Implement plan recommendations through city-led legislative rezonings and text amendments” (p. 79).

The purpose of this city-led legislative rezoning is to implement plan recommendations that are expressed in *Comprehensive Plan 2040*, *Blueprint Denver*, and the *Near Northwest Area Plan*.


Land Use and Built Form, Design Quality and Preservation Policy 4. “Ensure an active and pedestrian friendly environment that provides a true mixed-use character in centers and corridors” (p. 103).

The proposed Mixed Use and Main Street zone districts with the DO-8 promote active ground-floor uses and pedestrian friendly mixed-use areas.

Equity Concepts

Blueprint Denver has three equity concepts: improving access to opportunity, reducing vulnerability to displacement, and expanding housing and jobs diversity. *Blueprint Denver* states the equity concepts should be used to evaluate large area rezonings (p. 67) and therefore are applicable to this rezoning proposal. Staff uses Census-tract and neighborhood-wide data to measure these equity concepts. The information highlights what key issues or needs are present and points to potential options for improvements or mitigation.

Access to opportunity




The basis for measuring access to opportunity is a composite of the neighborhood equity index developed by Denver's Department of Public Health and Environment, proximity to high-capacity and frequent transit, and access to centers and corridors. Access to opportunity helps us to consider if we are making progress towards achieving the vision for complete neighborhoods across the city.

The Near Northwest Area's average Access to Opportunity score is between 2 and 4, out of 5. The lowest scores were in the Access to Transit category. Access to Centers and Corridors and Access to Parks were the highest scoring categories. The Neighborhood Equity Index scores, which is a measure of barriers to opportunity, vary somewhat across the area, but are generally moderate.

The proposed rezoning to include the DO-8 to the centers and corridors, supports commercial uses in these areas, which could bring more amenities and services to residents and improve the access to opportunity score. Additionally, some of the existing Former Chapter 59 properties will be rezoned into a mixed use district which will likewise allow a variety of commercial and residential uses.

Vulnerability to Displacement




The basis for measuring vulnerability to displacement is the vulnerability to displacement index developed by the Denver Economic Development and Opportunity office. This combines data from median household income, percentage of people who rent housing, and percent of population with less than a college degree. This concept is used to stabilize “residents and businesses who are vulnerable to involuntary displacement due to increasing property values and rents” (p. 30).

Chaffee Park and the northern portion of Sunnyside are the most vulnerable to involuntary displacement, scoring as vulnerable on two of the three measures of the index. The areas score as more vulnerable on percent of population with less than a bachelor’s degree and median household income. The areas within the Near Northwest are considered less vulnerable scoring as vulnerable on one of the three metrics.

Rezoning to include the DO-8 will likely have little impact on vulnerability to involuntary displacement because it will require nonresidential active uses on the ground floor. Likewise, the Former Chapter 59 properties are proposed to be rezoned to a district that meets plan guidance and considers the existing use so residential properties are being rezoned to a residential zone district, having a negligible impact on displacement in the area.

Housing Diversity




Diversity of housing and jobs captures the city's vision for complete neighborhoods with equitable access to quality employment options and housing choices that accommodate households of different ages, sizes, and incomes.

Near Northwest has varied housing diversity, with the northern areas scoring as more diverse and the southern neighborhoods less diverse. Chaffee Park is the most diverse scoring as not diverse on 1 out of 5 indicators – percent of middle density housing (2-19 units). Jefferson Park and Highland score as not diverse on all 5 indicators - percent of middle density housing, home size diversity, owners compared to renters, housing costs, and number of affordable units.

The proposed rezoning for Near Northwest is a step into implementing the recommendations outlined in the Plan for better design outcomes in centers and corridors. New housing units would be allowed for a small portion of the ground floor and on higher floors. Additionally, the existing row houses will be rezoned into multi-unit districts with the Denver Zoning Code preserving the existing missing middle housing.

Jobs Diversity



Near Northwest has jobs that are mostly skewed towards retail, but some areas have more manufacturing, innovation, or a similar mix to the city as a whole. The areas without color do not have enough jobs to conduct the diversity analysis, which makes up a small portion of the Near Northwest.

The proposed rezoning of the centers and corridor in Near Northwest would bring more commercial uses potentially increasing the job mix in the area. The Former Chapter 59 properties are rezoning into a variety of districts including some mixed use that would allow for a range of jobs.

Near Northwest Area Plan

Land Use Policy 2. "Consistent with adopted citywide policies in Blueprint Denver and in coordination with citywide efforts, elevate the design of buildings, streets and public spaces within centers, corridors, and high and high-medium residential areas" (p. 38-39).

- **Strategies B.** "Within centers, and corridors, high and high-medium residential areas encourage more pedestrian-friendly frontages that increase comfort, safety, and visual interest at the ground floor. Key considerations include:" (p. 38-39).
- "Limit auto-oriented building forms and uses, such as drive-thrus and fueling stations, particularly where a higher concentration exists, such as Chaffee Park" (p. 38-39).
- "Encourage better design outcomes and inviting spaces such as small commercial courtyards/patios by allowing more space for landscaping/streetscape especially along arterials. Consider increased setbacks and adjustments to build-to requirements" (p. 38-39).

Mapping the Active Centers and Corridors Design Overlay (DO-8) will encourage pedestrian-friendly frontages by prohibiting the drive-thru building forms and increasing the required setbacks and build-to to accommodate more space for patios and the sidewalk consistent with the above recommendation.

Land Use Policy 3. "Consistent with adopted citywide policies in Blueprint Denver and in coordination with citywide efforts, strengthen and expand commercial areas within centers and corridors to provide

spaces for residents to access goods and services, gathering spaces, and dining and entertainment options” (p. 40-41).

- **Strategies A.** “Create vibrant mixed-use places with a variety of retail, office, entertainment, civic, and residential uses that serve the community’s needs and are welcoming to all. Require ground-floor active or commercial uses at critical locations within centers and corridors” (p. 40-41).
- “Require an active mix of uses at the street level in areas designated as corridors and centers along former streetcar corridors. Consider updates to zoning standards or applying a design overlay, such as the Active Centers and Corridors Overlay” (p. 40-41).
- “Other key locations to promote active ground-floor uses include: mobility hubs, bus stops, and intersections of arterial and collector streets” (p. 40-41).

The development standards found within the DO-8 implement many of the strategies called for in Land Use Policy 3. The proposed zone districts standards will promote ground floor active uses and create pedestrian-friendly frontages.

Land Use Policy 11. “Consistent with adopted citywide policies in Blueprint Denver and in coordination with citywide efforts, support regulatory efforts to improve design outcomes, equity and responsiveness to evolution in zoning regulations” (p. 56-57).

- **Strategy A.** “Support rezoning out of Former Chapter 59 and into the Denver Zoning Code to improve design outcomes, equity and responsiveness to evolution in zoning regulations” (p. 56-57).
 - “Rezone properties from Former Chapter 59 into zone districts from the Denver Zoning Code. Align rezoning with the land use guidance from this plan and additional information gathered from further studies and community engagement (p. 56-57).
- **Strategy B.** “Implement legislative rezoning to address larger scale areas to reflect the land use recommendations of the Near Northwest Area Plan” (p. 56-57).

This proposal includes 33 instances of Former Chapter 59 zoning that will be rezoned to standard zone districts in the Denver Zone Code, which will improve design outcomes, equity, and responsiveness to evolution in zoning regulations.

Uniformity of District Regulations

The proposed official map amendment results in regulations and restrictions that are uniform for each kind of building throughout each district having the same classification and bearing the same symbol or designation on the official map, but the regulations in one district may differ from those in other districts.

The proposed rezonings will result in the uniform application of zone district building form, use, and design regulations.

Public Health, Safety, and General Welfare

The proposed official map amendment furthers the public health, safety, and general welfare of the City.

The proposed rezoning furthers the public health, safety, and general welfare of the City because it directly implements adopted policy from *Comprehensive Plan 2040*, *Blueprint Denver*, and the *Near Northwest Area Plan*. Additionally, mapping the DO-8 along centers and corridors will ensure these areas

will continue to provide amenities and services to nearby residents. It will also promote mixed use developments which has been found to increase physical activity¹ and support overall health².
