

#### FOURTH AMENDATORY AGREEMENT

THIS FOURTH AMENDATORY AGREEMENT is made and entered into by and between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the "City"), and **TYLER TECHNOLOGIES, INC.**, a Delaware corporation having its principal place of business at 5949 Sherry Lane, Suite 1400, Dallas, Texas 75225 (the "Vendor").

#### WITNESSETH:

WHEREAS, the City and the Vendor entered into an Agreement dated June 12, 2007, and amended on April 22, 2008, October 30, 2009 and December 27, 2011, to provide annual software maintenance on the City's CAMA and OASIS systems (the "Agreement"); and

WHEREAS, the City and the Vendor wish to amend the Agreement to extend the term and to increase the compensation to the Vendor; and

NOW, THEREFORE, in consideration of the premises and the mutual covenants and obligations herein set forth, the parties agree as follows:

1. Article 3(D)(i) of the Agreement entitled "Maximum Contract Liability" is hereby amended to read as follows:

**"D. Maximum Contract Liability:**

(i) Any other provision of this Agreement notwithstanding, in no event shall the City be liable for payment for services rendered and expenses incurred by the Vendor under the terms of this Agreement for any amount in excess of the sum of \$969,720.00. The Vendor acknowledges that any work performed by Vendor beyond that specifically authorized by the City is performed at Vendor's risk without authorization under this Agreement."

2. This Fourth Amendatory Agreement may be executed in two (2) counterparts, each of which shall be deemed to be an original, and all of which, taken together, shall constitute one and the same instrument.

3. Except as herein amended, this Fourth Amendatory Agreement affirmed and ratified in each and every particular.
