5 **Laying out, opening and establishing as part of the city street system, as part**
6 **of the streets listed below, certain real property in Stapleton Filing No. 22.**

8 **WHEREAS**, the Manager of Public Works of the City and County of Denver has found and
9 determined that the public use, convenience and necessity require the laying out, opening and
10 establishing as public streets designated as part of the system of thoroughfares of the municipality
11 those portions of real property hereinafter more particularly described, and, subject to approval by
12 resolution has laid out, opened and established the same as the public streets listed below;

13 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF**
14 **DENVER:**

16 **Section 1.** That the action of the Manager of Public Works in laying out, opening and
17 establishing as part of the system of thoroughfares of the municipality the following described
18 portions of real property situate, lying and being in the City and County of Denver, State of
19 Colorado, to wit:

(1) Trenton St., from 21st Ave. north to 22nd Pl., the land in the following described area:

Tract A, Stapleton Filing No. 22, City and County of Denver, State of Colorado;

(2) Tamarac St., from 21st Ave. north to 22nd Pl., the land in the following described area:

Tract B, Stapleton Filing No. 22, City and County of Denver, State of Colorado;

(3) Ulster St., from 21st Ave. north to and through, 22nd Pl. (Stapleton Filing No. 10), the
land in the following described area:

Tract C, Stapleton Filing No. 22, City and County of Denver, State of Colorado;

(4) 22nd Ave., from Ulster St. east to East Boundary Line of Stapleton Filing No. 22, the
land in the following described area:

20 **Tract D, Stapleton Filing No. 22, City and County of Denver, State of Colorado;**

(5) 21st Ave., from Spruce St. east to and through Ulster St., the land in the following described
area:
