REQUESTED COUNCIL ACTION

- Approval of contract with **Jacobs Engineering Group Inc.**, Contract No. PLANE-202476380
- **Amount:** Task Order Based Contract, not to exceed \$150,000,000. Allows specific tasks or services to be outlined and issued as needed. Each task order will detail the scope, deliverables, timelines, and payment terms for the specific task.
- **Term:** Date of Execution plus 10 Years
- **Purpose:** Denver International Airport (DEN) plans to form a Program Management Team (PMT) to oversee the development of two major projects: a state-of-the-art Consolidated Rental Car Facility (ConRAC) and a Common Transportation System (CTS). The ConRAC will centralize rental car brands in one location, while the CTS will ensure convenient travel between the Jeppesen Terminal and the ConRAC facility.

CONTRACT OVERVIEW

Program Management Team (PMT) Overview

- The PMT's scope of work includes a wide range of services essential for the successful completion of the ConRAC and CTS projects.
- These services encompass program and project management, environmental services, programmatic design and baseline development, permitting, and delivery method evaluation.
- The PMT will also assist with program oversight, cost and schedule management, risk management, quality assurance, and community engagement, among other responsibilities.

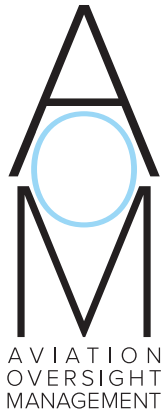
CONTRACT COMMUNITY OUTREACH

- In collaboration with Commerce Hub, outreach events were conducted on August 8, 2024, September 12, 2024, and October 10, 2024, as part of DEN Strategic Outreach and Engagement's "Taking Flight at DEN" initiative.
- Additionally, DEN held industry sessions (forums) with hundreds of attendees, fostering engagement and collaboration with the community and industry stakeholders, including MWBE firms.

CONTRACT MWBE GOALS

- The Division of Small Business Opportunity (DSBO) has set a 25% Minority and Women Business Enterprise (MWBE) goal for this opportunity, and Jacobs Engineering Group Inc. is committed to meeting or exceeding this goal.
- Jacobs' record of MWBE participation demonstrates their success in promoting diversity and inclusion in contracting.
- At DEN, Jacobs has engaged more than 30 MWBE firms, delivering over \$40 million in professional services across 12 different contracts in the past five years. Additionally, Jacobs has helped five businesses establish Denver offices and achieve MWBE certification, thereby increasing the diversity of DEN's supplier base.

CONTRACT SELECTION PROCESS

Executive Order 8 required a competitive selection process. DEN issued an RFQ on October 28, 2025, with responses due by December 16, 2024. Six entities submitted proposals.

An Independent Evaluation Panel, approved by the DEN CEO, shortlisted the top three on January 22, 2025.

After reviewing proposals and interviews, the panel identified Jacobs Engineering Group Inc. as the best proposer on February 12, 2025.

IMPACT/BENEFITS

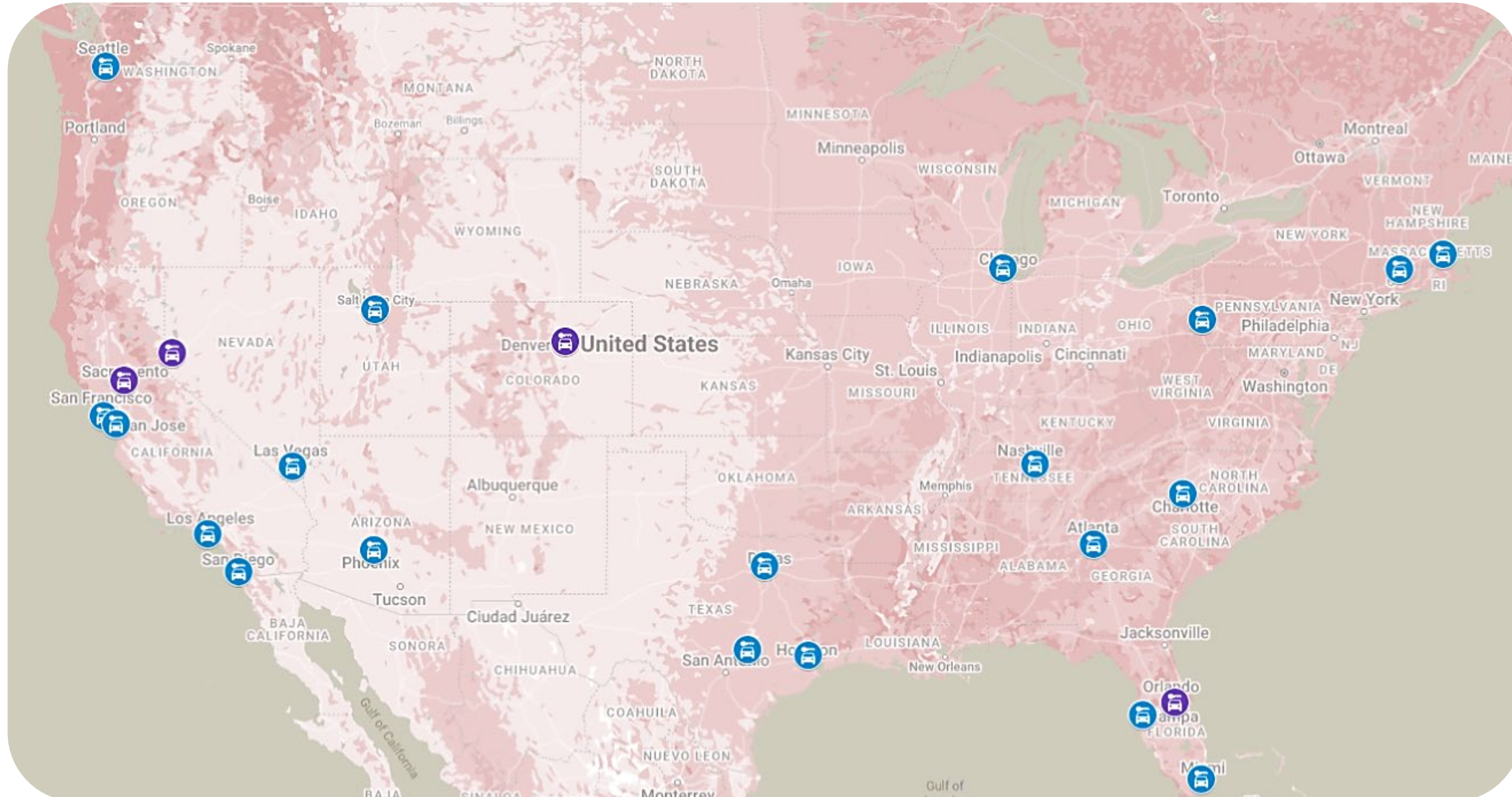
DEN is a major transportation hub, accommodating over 82 million passengers annually. Despite its significant operational scale, DEN remains one of the few major airports without a ConRAC facility.

The development of a ConRAC and CTS at DEN presents several advantages:

- **Creating a Modern Facility:** Enhance passenger experience with a state-of-the-art, efficient, and streamlined facility.
- **Reducing Terminal Traffic:** Decrease congestion around the terminal by minimizing shuttle usage.
- **Promoting Sustainability:** Reduce environmental impact by eliminating the need for 250,000 shuttle trips per year, contributing to greener airport operations. Additionally, the inclusion of electric vehicle (EV) infrastructure, such as Level 1 and Level 2 chargers and conduit, ensures the facility is EV-ready for a seamless transition to full EV adoption.

Annual Sales Tax Figures: Currently, Rental Cars operating on airport property contribute just shy of about \$60M a year to the CCD in annual sales tax revenue.

- These projects will enhance passenger experience, reduce terminal traffic, and promote sustainability, aligning with DEN's Vision 100 goals.
