SERIES OF 2011 COMMITTEE OF REFERENCE: **Government Affairs and Finance ABILL** For an ordinance establishing a "DAM Hamilton Building Rehab/Improvements" fund in the Grant/Other Capital Projects Fund and the means for authorizing expenditures therefor. WHEREAS, the City and County of Denver desires to establish a capital maintenance and capital improvement special revenue fund for Denver Art Museum Hamiliton Building capital projects; WHEREAS, the City and County of Denver has received \$15,000,000 (fifteen million dollars) as part of a settlement and release, said monies to be deposited into this fund; and **WHEREAS**, a new fund number is required to be created for said projects;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. There is hereby established in the Grants/Other Capital Projects Fund, Accounting No. 38000, a "DAM Hamilton Building Rehab/Improvements" Fund, Accounting No. 38304-5011102 for the purpose of collecting revenue and handling other financial transactions related to capital projects for the Denver Art Museum Hamilton Building.

Section 2. Monies received from grants, settlements (including the settlement referred to above), transfers from other funds, rebates and other project incomes or source of private receipts received for said purpose shall be deposited into the Treasury of the City and credited to Grant/Other Capital Projects Fund No. 38000 which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver. Interest and other investment income shall be retained by the "DAM Hamilton Building Rehab/Improvements" fund.

Section 3. Monies described in Section 2 of this Ordinance are designated for the specific purpose of repairs, improvements and betterment of the Hamilton Building's vapor and water barrier systems. After the vapor and water barrier system work is completed, monies are designated for capital improvement first and capital maintenance if any such receipts remain.

Section 4. Expenditures are hereby authorized for the "DAM Hamilton Building Rehab/Improvements" Fund, Accounting No. 38304-5011102-ZM100, in the amount not to exceed the total of deposits described in Section 2 of this Ordinance, to be expended by the Manager of Public Works.
