### Scope of work:

Rapid Resolution is the use of engagement and case management skills along with a household's protective factors to resolve an episode of housing instability or homelessness. The goal of Rapid Resolution is to explore creative, flexible, safe, and cost-effective solutions to quickly resolve the housing crisis through:

1. Prevention: mediation, support, or problem solving with a landlord, roommates, and or family to keep someone in current housing
2. Diversion: problem solving with a household to divert them to temporary or permanent housing rather than entering the shelter system
3. Rapid Exit: working with a household who is receiving services at a shelter to get them rehoused as quickly as possible.
