4 **A RESOLUTION**

5 **Laying out, opening and establishing as part of the City street system parcels of**
6 **land as a public alley near the intersection of North Irving Street and West 17th**
7 **Avenue.**

8 **WHEREAS**, the Executive Director of Public Works of the City and County of Denver has
9 found and determined that the public use, convenience and necessity require the laying out, opening
10 and establishing as a public alley designated as part of the system of thoroughfares of the
11 municipality those portions of real property hereinafter more particularly described, and, subject to
12 approval by resolution has laid out, opened and established the same as a public alley;

13 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

14 **Section 1.** That the action of the Executive Director of Public Works in laying out, opening
15 and establishing as part of the system of thoroughfares of the municipality the following described
16 portions of real property situate, lying and being in the City and County of Denver, State of Colorado,
17 to wit:

19 THOSE PARCELS OF LAND DESCRIBED AS PARCEL "A" AND PARCEL "B", CONVEYED BY
20 WARRANTY DEED TO THE CITY & COUNTY OF DENVER, RECORDED ON THE 8th OF AUGUST 2016,
21 BY RECEPTION NO. 2016106565 IN THE CITY AND COUNTY OF DENVER, CLERK AND RECORDER'S
22 OFFICE, BEING DESCRIBED AS FOLLOWS:

23 **Parcel "A"**

24 THE WESTERLY 3.00 FEET OF LOTS 1 AND 2, BLOCK 21, GURLEY'S RESUBDIVISION OF
25 CHELTENHAM HEIGHTS, CITY AND COUNTY OF DENVER, STATE OF COLORADO. CONTAINS 183
26 SQUARE FEET, MORE OR LESS.

27 **Parcel "B"**

28 THE WESTERLY 3.00 FEET OF LOT 3 AND THE WESTERLY 3.00 FEET OF THE NORTH 1/3 OF LOT 4,
