Colorado Coalition for the Homeless (CCH) has successfully applied for 26 additional housing vouchers from the Colorado Division of Housing and wishes to amend the funding agreement and the affordability covenant to reflect the updated unit counts. The new unit distribution lends to the shared vision of the property eventually operating the entirely as permanent supportive housing.

This amendment will adjust the non-congregate shelter (NCS) unit count down from 107 to 81 and the supportive housing unit count up from 108 to 134. All of the newly vouchered units will be reclassified as 50% HOME-ARP units. The table below summarizes the proposed adjustment.
