That the proposed Central Park Station Area Plan, consisting of a document 24 of the same name filed with the City Clerk, Ex-Officio Clerk of the City and County of Denver, on the day of , 2012, as City Clerk Filing No. 12- , is hereby accepted and 25 26 adopted as part of the Comprehensive Plan, pursuant to Section 12-61 of the DRMC. 27 **Section 2.** That this acceptance of the Central Park Station Area Plan, and of any 28 amendment thereto, is intended to establish the same, in conjunction with the Comprehensive 29 Plan, as the official guide for officials of the City and County of Denver and private citizens 30 when making decisions affecting the future of the Central Park Station Area, as defined in said 31 plan; provided however, that such approval shall not preempt the decision making powers 32 vested by law or administrative directive in the Mayor, the Council or any other official of the 33 City and County of Denver with respect to, but not limited to: a zoning map amendment, a 34 zoning language amendment, a dedication or vacation of a street, alley or other public way, a

designation of a park, the issuance of a revocable permit, a conveyance or acquisition of real

property by the City and County of Denver, or an appropriation for or construction of a capital
